Explanation of Appropriation. (C)

This \$13,823 ordinance appropriates from Tourist Development Council fund balance to the TDC Administration activity to provide funding for the salaries, benefits, and office expenses of the administrator position through September 30, 2022.

Section 2. Purpose. The purpose of the appropriation in 11 Section 1 is to provide funding for the creation of the job position 12 of administrator in order to provide administrative and office support 13 to the TDC and its executive director. 14

Section 3. Approval of Position. 15 There is hereby approved the position more fully described in R.C. 22-164, attached 16 hereto as Exhibit 2 and incorporated herein by this reference. 17

18 Section 4. Requesting emergency one cycle passage pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this 19 20 legislation is requested. The nature of the emergency is that the 21 appropriation is needed in order to fill the administrator position 22 as soon as possible.

23 Section 5. Effective Date. This Ordinance shall become 24 effective upon signature by the Mayor or upon becoming effective 25 without the Mayor's signature.
