4 **ORDINANCE 2022-579**

5 AN ORDINANCE SUPPLEMENTING ORDINANCE 2006-888-E
6 AUTHORIZING THE ISSUANCE OF THE CITY'S SPECIAL
7 REVENUE BONDS, IN ONE OR MORE SERIES IN AN AMOUNT
8 NECESSARY TO PROVIDE NOT IN EXCESS OF
9 \$120,000,000 OF NET PROJECT FUNDS IN ORDER TO
10 FINANCE AND REFINANCE THE ACQUISITION AND
11 CONSTRUCTION OF CERTAIN CAPITAL EQUIPMENT AND
12 IMPROVEMENTS (THE "SERIES 2022C PROJECT");
13 PROVIDING AUTHORITY FOR THIS ORDINANCE;
14 PROVIDING FOR CERTAIN DEFINITIONS; MAKING
15 CERTAIN FINDINGS; PROVIDING THAT THIS ORDINANCE
16 SHALL CONSTITUTE A CONTRACT BETWEEN THE ISSUER
17 AND THE BONDHOLDERS; AUTHORIZING THE MAYOR TO
18 DETERMINE THE TERMS OF SUCH BONDS, AS PROVIDED
19 HEREIN; AUTHORIZING THE MAYOR TO AWARD THE SALE
20 OF SAID BONDS ON A COMPETITIVE BASIS, A LIMITED
21 COMPETITIVE BASIS, A NEGOTIATED BASIS, OR AS A
22 PRIVATE PLACEMENT, AS PROVIDED HEREIN;
23 AUTHORIZING THE ACQUISITION OF DEBT SERVICE
24 RESERVE FUND PRODUCTS WITH RESPECT TO SUCH
25 BONDS, IF DEEMED NECESSARY; AUTHORIZING THE
26 ACQUISITION OF CREDIT FACILITIES WITH RESPECT TO
27 SUCH BONDS, IF DEEMED NECESSARY; AUTHORIZING
28 THE PREPARATION OF PRELIMINARY AND FINAL
29 OFFICIAL STATEMENTS AND/OR OFFERING MEMORANDA

1 WITH RESPECT TO SUCH BONDS; AUTHORIZING THE
2 EXECUTION OF A CONTINUING DISCLOSURE UNDERTAKING
3 OR AGREEMENT WITH RESPECT TO SUCH BONDS;
4 AUTHORIZING THE DESIGNATION OF A DEPUTY
5 REGISTRAR AND PAYING AGENT AND THE PROVIDERS OF
6 OTHER SERVICES WITH RESPECT TO SUCH BONDS;
7 PROVIDING FOR THE APPLICATION OF SUCH BOND
8 PROCEEDS; AUTHORIZING THE EXECUTION OF A BOND
9 TERMS AGREEMENT WITH RESPECT TO SAID BONDS;
10 PROVIDING CERTAIN ADDITIONAL DETAILS AND
11 AUTHORIZATIONS IN CONNECTION THEREWITH; WAIVING
12 THE PROVISIONS OF SECTION 104.211 (PROCEDURE FOR
13 SALE OF BONDS) OF CHAPTER 104 (BONDS), *ORDINANCE*
14 *CODE*, SO AS TO ALLOW THE CITY TO AWARD THE SALE
15 OF SAID BONDS ON A LIMITED COMPETITIVE BASIS, AS
16 A NEGOTIATED SALE, OR AS A PRIVATE PLACEMENT;
17 PROVIDING AN EFFECTIVE DATE.

19 **WHEREAS**, the City Council of the City of Jacksonville, Florida
20 (the "Council") previously enacted Ordinance 2006-888-E (as amended
21 and supplemented, including by this Supplemental Ordinance, the
22 "Special Revenue Bond Ordinance") providing for the issuance of bonds
23 known as "Special Revenue Bonds" of the City of Jacksonville, Florida
24 (the "Issuer") to be paid from Covenant Revenues of the Issuer
25 budgeted and appropriated as provided in the Special Revenue Bond
26 Ordinance and deposited into the funds and accounts created
27 thereunder, all in the manner provided in the Special Revenue Bond
28 Ordinance; and

1 **WHEREAS**, the Issuer initially financed certain capital
2 improvements through its commercial paper program, which provides
3 short term financing; and

4 **WHEREAS**, the Issuer's Financial Advisor has recommended and the
5 Council has determined that it is in the best interests of the Issuer
6 to authorize the issuance of Additional Bonds under the Special
7 Revenue Bond Ordinance as supplemented hereby in order to finance and
8 refinance the acquisition and construction of certain capital
9 equipment and improvements for the Issuer, and pay the costs of
10 issuance related thereto, all as more particularly described in
11 **Exhibit 1**, attached hereto, as the same may be supplemented from time
12 to time; and

13 **WHEREAS**, Section 12.02 of the Special Revenue Bond Ordinance
14 provides for the issuance of Additional Bonds under the terms,
15 limitations, and conditions provided therein and the Issuer has
16 complied with Section 12.02 of the Special Revenue Bond Ordinance or
17 will comply therewith prior to issuance of the Series 2022C Bonds,
18 to the extent required therein, and is, or will be, therefore, legally
19 entitled to issue the Series 2022C Bonds as Additional Bonds; now
20 therefore

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Authority For This Supplemental Ordinance.** This
23 Supplemental Ordinance is enacted pursuant to the Act and the Special
24 Revenue Bond Ordinance.

25 **Section 2. Definitions.** All terms used herein in capitalized
26 form, unless otherwise defined herein or unless the context clearly
27 indicates some other meaning, shall have the same meaning as ascribed
28 to them in the Special Revenue Bond Ordinance. In addition, as used
29 herein, unless the context clearly indicates some other meaning:

1 "Approved Underwriters" means those approved investment banking
2 firms selected from time to time by the Issuer pursuant to its
3 selection procedures with respect to such services, who may also
4 serve as a private placement agent in the case of a private placement
5 to institutional investors.

6 "Bond Terms Agreement" shall have the meaning provided in
7 Section 14(a) hereof.

8 "Chief Financial Officer" means the Chief Financial Officer or
9 other officer of the Issuer serving as the chief financial officer
10 as defined in Section 218.403, Florida Statutes.

11 "Financial Advisor" means the individual(s) or firm(s) retained
12 by the Issuer to provide financial advisory services with respect to
13 debt issued by the Issuer.

14 "Issuer" shall have the meaning ascribed thereto in the recitals
15 to this Supplemental Ordinance.

16 "Mayor" means the Mayor of the Issuer or his or her designee or
17 alternative officer authorized by ordinance of the Issuer or executive
18 order.

19 "Series 2022C Bonds" means the Additional Bonds authorized
20 hereunder to be issued, from time to time, in one or more Series to
21 finance the Series 2022C Project.

22 "Series 2022C Project" means certain capital equipment and
23 improvements for the Issuer, all as more particularly described in
24 **Exhibit 1**, attached hereto, as the same may be supplemented by a Bond
25 Terms Agreement from time to time, and includes capital equipment and
26 improvements previously financed through the Issuer's commercial
27 paper program.

28 "Special Revenue Bond Ordinance" shall have the meaning ascribed
29 thereto in the recitals to this Supplemental Ordinance.

1 "Supplemental Ordinance" means this ordinance supplementing the
2 Special Revenue Bond Ordinance.

3 **Section 3. Findings.**

4 (a) The Issuer previously enacted the Special Revenue Bond
5 Ordinance providing for the issuance of Bonds to be paid from Covenant
6 Revenues of the Issuer budgeted and appropriated as provided in the
7 Special Revenue Bond Ordinance and deposited into the funds and
8 accounts created thereunder, all in the manner provided in the Special
9 Revenue Bond Ordinance.

10 (b) The findings and declarations of the Issuer in the Special
11 Revenue Bond Ordinance are hereby expressly approved, ratified, and
12 confirmed.

13 (c) The improvements comprising the Series 2022C Project have
14 been previously authorized by the Issuer and a portion have been
15 initially financed through the Issuer's commercial paper program.
16 Based on the advice of the Issuer's Financial Advisor, the Issuer has
17 determined that it is desirable and in the best interests of the
18 Issuer to finance and refinance the Series 2022C Project by the
19 issuance of the Series 2022C Bonds.

20 (d) The Issuer is authorized by the Act, the Special Revenue
21 Bond Ordinance, and this Supplemental Ordinance to issue the Series
22 2022C Bonds, from time to time, in one or more Series to finance and
23 refinance the Series 2022C Project and to pay the costs of issuance
24 thereof.

25 (e) Upon issuance, in accordance with the terms hereof, the
26 Series 2022C Bonds shall constitute Additional Bonds under the Special
27 Revenue Bond Ordinance, entitled to all of the security and benefits
28 thereof.

1 (f) It is estimated that the Covenant Revenues available to be
2 budgeted and appropriated as provided in the Special Revenue Bond
3 Ordinance will be sufficient to pay all principal of and interest on
4 the Series 2022C Bonds to be issued hereunder, and all other Bonds
5 and Additional Bonds issued under the Special Revenue Bond Ordinance,
6 as the same become due and payable, and to make all sinking fund,
7 reserve, and other payments in connection therewith.

8 (g) Because of the characteristics of the Series 2022C Bonds,
9 the source of security and payment thereof, prevailing and anticipated
10 market conditions, the need for flexibility in timing the issuance
11 and sale of the Series 2022C Bonds, the need to allow for a timely
12 sale of the Series 2022C Bonds together with other refunding Special
13 Revenue Bonds, advantages expected to be received from an enhanced
14 marketing of the Series 2022C Bonds afforded by engaging one or more
15 investment banking firms in a negotiated sale, or, in some market
16 conditions, a private placement to institutional investors, in
17 consultation with the Chief Financial Officer and the Issuer's
18 Financial Advisor, it is necessary and in the best interests of the
19 Issuer to waive the provisions of Section 104.211 (Procedure for Sale
20 of Bonds) of Chapter 104 (Bonds), *Ordinance Code*, and authorize the
21 sale of the Series 2022C Bonds at a limited competitive or negotiated
22 sale or sales or as a private placement to institutional investors,
23 as provided herein.

24 **Section 4. Instrument to Constitute Contract.** In
25 consideration of the acceptance of the Series 2022C Bonds authorized
26 to be issued hereunder by those who shall own the same from time to
27 time, the Special Revenue Bond Ordinance, as supplemented by this
28 Supplemental Ordinance and certain Bond Terms Agreements to be
29 delivered by the Mayor as provided in Section 14(a) hereof providing

1 the terms and details of the Series 2022C Bonds, shall be and
2 constitute a contract between the Issuer and the registered owners
3 of the Series 2022C Bonds. The covenants and agreements set forth
4 herein, in such Bond Terms Agreements and in the Special Revenue Bond
5 Ordinance, to be performed by the Issuer shall be for the equal
6 benefit, protection, and security of the registered owners of the
7 Series 2022C Bonds, and the Series 2022C Bonds shall constitute Bonds
8 under the Special Revenue Bond Ordinance and shall be of equal rank
9 with all other Series 2022C Bonds and with all other Bonds from time
10 to time Outstanding under the Special Revenue Bond Ordinance, without
11 preference, priority, or distinction over any other thereof except
12 as may be expressly provided herein or in the Special Revenue Bond
13 Ordinance. All covenants in the Special Revenue Bond Ordinance shall
14 be fully applicable to the Series 2022C Bonds.

15 **Section 5. Authorization of Financing and Refinancing the**
16 **Series 2022C Project.** The financing and refinancing of the Series
17 2022C Project is hereby authorized and approved. Any portion of the
18 Series 2022C Project not otherwise financed by the issuance of Series
19 2022C Bonds may, as determined by the Mayor in consultation with the
20 Chief Financial Officer and the Issuer's Financial Advisor, be
21 financed or refinanced through the City's Commercial Paper Program.

22 **Section 6. Authorization and Terms of the Series 2022C Bonds.**

23 (a) Subject and pursuant to the provisions hereof, particularly
24 the provisions of Section 5 above, and of the Special Revenue Bond
25 Ordinance, Additional Bonds to be known as the "City of Jacksonville,
26 Florida Special Revenue Bonds, Series 2022C" (or if such Series 2022C
27 Bonds are issued in more than one Series, or are not issued in
28 calendar year 2022, such other name or series designation as the
29 Mayor shall direct) are hereby authorized to be issued in one or more

1 Series and in the original aggregate principal amount necessary to
2 provide not in excess of \$120,000,000 of net funds available for the
3 financing and refinancing of the Series 2022C Project (exclusive of
4 costs of issuance and the funding of any reserves), provided all
5 limitations and other delegation criteria provided herein have been
6 met. The Series 2022C Bonds may be issued together with other Special
7 Revenue Bonds or Special Revenue Refunding Bonds of the Issuer.

8 (b) The Series 2022C Bonds of each Series or installment shall
9 finally mature, taking into account any subsequent roll-overs and
10 refundings of any Series 2022C Bonds issued as Designated Maturity
11 Debt, not later than thirty-one years from the date of original
12 issuance and delivery of each such Series or installment of Series
13 2022C Bonds. Subject to such maturity limitation, the Mayor is hereby
14 authorized to determine the dates of maturity of the Series 2022C
15 Bonds and, as applicable, designate all or a portion thereof as
16 Designated Maturity Debt for purposes of the Special Revenue Bond
17 Ordinance. Such determination by the Mayor shall be based upon his
18 determination, in consultation with the Chief Financial Officer and
19 the Issuer's Financial Advisor, existing and anticipated market
20 conditions and the Issuer's debt profile, that the debt structure is
21 in the best financial interests of the Issuer. The authorization
22 provided herein shall include the authorization to refund and rollover
23 Series 2022C Bonds issued as Designated Maturity Debt from time to
24 time, provided that such maturity limit and the other delegation
25 criteria provided herein shall apply to such refundings and rollovers.

26 (c) The Series 2022C Bonds shall bear such interest rate or
27 rates, not to exceed the maximum rates permitted by applicable law
28 and the Special Revenue Bond Ordinance, as shall be determined by the
29 Mayor in the applicable Bond Terms Agreement and as shall comply with

1 the Issuer's Debt Management Policy. Such determination by the Mayor
2 shall be based upon his determination, in consultation with the Chief
3 Financial Officer and the Issuer's Financial Advisor, existing and
4 anticipated market conditions, the Issuer's debt profile, the
5 Issuer's Debt Management Policy and the terms and conditions of the
6 Special Revenue Bond Ordinance, that such rate or rates are in the
7 best financial interests of the Issuer. In establishing fixed
8 interest rates, the Mayor shall rely on the opinion of the Issuer's
9 Financial Advisor that such rate or rates are fair and reasonable
10 based upon existing and anticipated market conditions. Such interest
11 rate or rates may be fixed rates, adjustable rates, or variable rates,
12 including without limitation, variable rates determined by reference
13 to a percentage of an index or of a benchmark or reference interest
14 rate and may include such adjustments as the Mayor shall deem fair
15 and reasonable in reliance upon the opinion of the Issuer's Financial
16 Advisor that such rates and adjustments are fair and reasonable based
17 upon existing and anticipated market conditions, or daily, weekly or
18 term interest rates which are reset periodically by a remarketing
19 agent, generally as the minimum rate or rates as will, in the
20 reasonable judgment of such remarketing agent, allow such Series
21 2022C Bonds to be remarketed at par. The Mayor is hereby authorized
22 to determine term rate periods for any Series 2022C Bonds bearing
23 interest at term rates.

24 (d) The Series 2022C Bonds may be issued as current interest
25 paying bonds, Serial Bonds, Term Bonds, and/or Designated Maturity
26 Debt, as determined by the Mayor. The Mayor is hereby authorized to
27 determine the dated date or dates, interest payment dates, the
28 authorized denominations, the provisions with respect to registration
29 and transfer, the medium of payment, the place or places of payment,

1 the optional and mandatory redemption terms and conditions (including
2 notice requirements), if any, optional and mandatory tender for
3 purchase provisions, terms and conditions, if any, and such other
4 terms and conditions with respect to the Series 2022C Bonds as shall
5 be consistent with the Issuer's Debt Management Policy, the provisions
6 of the Special Revenue Bond Ordinance and this Supplemental Ordinance,
7 all as may be specified in the applicable Bond Terms Agreement. Such
8 determination by the Mayor shall be based upon the Mayor's
9 determination, in consultation with the Chief Financial Officer and
10 the Issuer's Financial Advisor, as to whether such provisions, terms
11 and conditions are fair and reasonable and comply with market norms,
12 and that the provisions, terms and conditions with respect to the
13 Series 2022C Bonds are in the best financial interest of the Issuer.
14 Any installment or maturity of Series 2022C Bonds determined by the
15 Mayor to be issued as Designated Maturity Debt is hereby designated
16 as "Designated Maturity Debt" for purposes of the Special Revenue
17 Bond Ordinance. An amount in each Bond Year equal to the principal
18 amount of Series 2022C Bonds required to be redeemed in such Bond
19 Year prior to and including the maturity thereof pursuant to mandatory
20 sinking fund redemptions as designated by the Mayor pursuant hereto
21 are hereby designated as "Amortization Installments" as that term is
22 defined in the Special Revenue Bond Ordinance. The Issuer may satisfy
23 its obligations to make Amortization Installments with respect to the
24 Series 2022C Bonds, on or before the 45th day next preceding each
25 principal payment date on which Series 2022C Bonds are to be retired
26 pursuant to Amortization Installments by delivering to the Deputy
27 Registrar and Paying Agent for cancellation, Series 2022C Bonds that
28 are Term Bonds of the maturity required to be redeemed on such
29 principal payment date in any aggregate principal amount desired.

1 Upon such delivery, the Issuer shall receive a credit against the
2 amounts required to be deposited in the Debt Service Account on
3 account of such Term Bonds in an amount equal to 100% of the principal
4 amount of any of the Term Bonds so purchased and cancelled.

5 **Section 7. Sale of Series 2022C Bonds.** The Mayor is hereby
6 authorized to award the sale of the Series 2022C Bonds, in one or
7 more Series or installments and from time to time as necessary to
8 finance and refinance the Series 2022C Project, pursuant to a
9 competitive, limited competitive or negotiated sale or sales to one
10 or more of the Approved Underwriters or as determined by the Mayor,
11 or to place the Series 2022C Bonds, or one or more installments
12 thereof, with one or more institutional investors. As a point of
13 clarification, the term institutional investors shall include, but
14 not be limited to, banking institutions. For a competitive sale, the
15 Series 2022C Bonds shall be awarded to the bidder offering to purchase
16 the Series 2022C Bonds at the lowest true interest cost as calculated
17 pursuant to the official notice of bond sale. The Mayor is hereby
18 authorized to execute and deliver any documents necessary to evidence
19 such award. In the event the Mayor determines, in consultation with
20 the Chief Financial Officer and the Issuer's Financial Advisor that
21 a limited competitive sale is in the best interests of the Issuer,
22 the Series 2022C Bonds shall be sold pursuant to a limited competitive
23 bidding process providing for competitive bids by pre-qualified
24 members of the Issuer's investment banking team and the sale of any
25 such Series 2022C Bonds shall be awarded to the bidder whose bid
26 produces the lowest true interest cost for the applicable term. In
27 the event the Mayor determines, in consultation with the Chief
28 Financial Officer and the Issuer's Financial Advisor, that a
29 negotiated sale or placement is in the best interests of the Issuer,

1 such sale or sales may be at prices and terms negotiated with one or
2 more of the Approved Underwriters or directly with an institutional
3 investor, determined in consultation with the Chief Financial Officer
4 and the Issuer's Financial Advisor that such prices and terms are
5 fair and reasonable based upon existing and anticipated market
6 conditions.

7 In connection with the sale of the Series 2022C Bonds, the Mayor
8 may execute and deliver and the Corporation Secretary shall attest
9 the execution of all necessary documents and agreements including one
10 or more bond purchase agreements with one or more of the Approved
11 Underwriters, or commitment letters or agreements with the
12 institutional investor or investors purchasing the Series 2022C
13 Bonds, in forms approved by the Office of General Counsel, with such
14 terms and conditions as shall be consistent with the terms of the
15 Special Revenue Bond Ordinance and this Supplemental Ordinance and
16 shall be in accordance with market norms. The Approved Underwriters
17 or institutional investors to whom the Series 2022C Bonds are sold,
18 or with whom they are placed, shall provide (i) a disclosure statement
19 regarding each such Series 2022C Bonds containing the information
20 required pursuant to Section 218.385(6), Florida Statutes, and (ii)
21 a Truth-In-Bonding Statement pursuant to Section 218.385(2), Florida
22 Statutes.

23 **Section 8. Series 2022C Bonds Reserve Requirement.** The Mayor,
24 in consultation with the Chief Financial Officer and the Issuer's
25 Financial Advisor, shall determine the Reserve Requirement, if any,
26 with respect to the Series 2022C Bonds and shall designate whether
27 or not the Series 2022C Bonds shall be secured by the Composite
28 Reserve Subaccount.

1 The Mayor is hereby authorized to bid, award and negotiate the
2 terms and provide for the acquisition of one or more Reserve Products
3 to fund all or a portion of the Reserve Requirement, if any, with
4 respect to the Series 2022C Bonds, consistent with the requirements
5 of the Special Revenue Bond Ordinance and as shall be recommended by
6 the Chief Financial Officer and the Issuer's Financial Advisor to be
7 in the best financial interests of the Issuer. The Mayor may execute
8 and deliver and the Corporation Secretary shall attest the execution
9 of such agreements (including one or more Bond Terms Agreement)
10 providing for the issuance of a Reserve Product acquired pursuant to
11 the foregoing authorization and providing such terms and agreements
12 with respect thereto, which shall be supplemental to the terms of the
13 Special Revenue Bond Ordinance and this Supplemental Ordinance, as
14 the Mayor shall approve and as shall be consistent with the provisions
15 of the Special Revenue Bond Ordinance and this Supplemental Ordinance.
16 Any such agreements shall be in a form approved by the Office of
17 General Counsel.

18 **Section 9. Bond Insurance Policy; Credit Facility.** The Mayor
19 is hereby authorized to award and negotiate the terms and provide for
20 the acquisition of one or more Bond Insurance Policies and/or Credit
21 Facilities to provide credit and/or liquidity enhancement with
22 respect to all or a portion of the Series 2022C Bonds, as shall be
23 consistent with the Special Revenue Bond Ordinance and recommended
24 by the Chief Financial Officer and the Issuer's Financial Advisor to
25 be in the best financial interests of the Issuer. The Mayor may
26 execute and deliver and the Corporation Secretary shall attest the
27 execution of all documents and agreements (including one or more Bond
28 Terms Agreement) providing for the issuance of a Bond Insurance Policy
29 or Credit Facility acquired pursuant to the foregoing authorization

1 and providing such terms and agreements with respect thereto, which
2 shall be supplemental to the Special Revenue Bond Ordinance and this
3 Supplemental Ordinance, as the Mayor shall approve and as shall be
4 consistent with the provisions of the Special Revenue Bond Ordinance
5 and this Supplemental Ordinance. Such documents and agreements may
6 provide that Series 2022C Bonds acquired pursuant to a drawing under
7 such Credit Facility or other reimbursement obligations with respect
8 to draws or advances under any such Bond Insurance Policy or Credit
9 Facility may bear interest at the rate or rates specified therein,
10 not to exceed the maximum rate permitted by applicable law.

11 **Section 10. Official Statements.**

12 (a) The Issuer hereby authorizes the preparation of a
13 Preliminary Official Statement and/or Placement Memorandum of the
14 Issuer with respect to the Series 2022C Bonds to be sold as authorized
15 herein, providing fair and accurate disclosure with respect to the
16 Series 2022C Bonds, the terms, security and source of payment therefor
17 and other relevant matters with respect thereto. The Mayor, upon the
18 advice of the Chief Financial Officer and the Office of General
19 Counsel, is hereby authorized to approve the form and content of each
20 such Preliminary Official Statement and/or Placement Memorandum and
21 to approve and authorize the distribution thereof to prospective
22 purchasers of the Series 2022C Bonds. The Mayor and the Chief
23 Financial Officer are each individually authorized, on behalf of the
24 Issuer, to deem each such Preliminary Official Statement and/or
25 Placement Memorandum "final", for purposes of Rule 15c2-12 of the
26 Securities and Exchange Commission (the "Rule"), subject to permitted
27 omissions under the Rule.

28 (b) The Issuer hereby authorizes the preparation and
29 distribution of a final Official Statement and/or Placement

1 Memorandum with respect to Series 2022C Bonds sold or to be sold as
2 authorized herein, providing fair and accurate disclosure with
3 respect to such Series 2022C Bonds, the terms, security and sources
4 of payment thereof and other relevant matters with respect thereto.
5 The Mayor, upon the advice of the Chief Financial Officer and the
6 Office of General Counsel, is hereby authorized to approve the form
7 and content of each such Official Statement and/or Placement
8 Memorandum and authorize and approve the distribution thereof in
9 connection with the issuance and sale and/or placement of the Series
10 2022C Bonds. Such Official Statement and/or Placement Memorandum
11 shall be executed on behalf of the Issuer by the Mayor and the Chief
12 Financial Officer. Execution and delivery of each such Official
13 Statement and/or Placement Memorandum shall be conclusive evidence
14 of approval thereof pursuant hereto.

15 **Section 11. Continuing Disclosure.** In order to assist the
16 Approved Underwriters in complying with the provisions of the Rule
17 requiring continuing disclosure with respect to the Series 2022C
18 Bonds, the Issuer hereby approves and authorizes the execution and
19 delivery of one or more continuing disclosure undertakings or
20 agreements with a dissemination agent in compliance with the Rule in
21 such form as shall be approved by the Mayor upon the advice of the
22 Chief Financial Officer and the Office of General Counsel. The Mayor
23 and the Corporation Secretary are hereby authorized to execute and
24 deliver each such continuing disclosure instrument, execution and
25 delivery thereof to be conclusive evidence of the approval thereof
26 pursuant hereto.

27 **Section 12. Agents and Services With Respect To Series 2022C**
28 **Bonds.** The selection and appointment of the Deputy Registrar and
29 Paying Agent, any escrow agents, verification agents, electronic

1 bidding platforms, the printers for Series 2022C Bonds and/or
2 preliminary and final official statements and services for the
3 electronic distribution thereof, and similar services with respect
4 to the Series 2022C Bonds, in accordance with the Issuer's existing
5 contracts or procedures for selection of providers of such services,
6 but without further Council approval under Part 3 of Section 126 of
7 the Ordinance Code, are hereby authorized and approved.

8 **Section 13. Application Of Proceeds Of Series 2022C Bonds.**

9 Proceeds from the sale of the Series 2022C Bonds shall be applied to
10 the financing and refinancing of the Series 2022C Project, the costs
11 of issuance thereof, including the funding of any reserves, in
12 accordance with the Code and as set forth in the applicable Bond
13 Terms Agreement.

14 **Section 14. Agreements With Respect To Series 2022C Bonds.**

15 (a) In order to implement the authorizations provided in this
16 Supplemental Ordinance and the Special Revenue Bond Ordinance and to
17 specify the terms and details of the Series 2022C Bonds as
18 contemplated and authorized hereby, the Mayor and the Corporation
19 Secretary are hereby authorized to execute and deliver one or more
20 certificates or agreements (referred to herein as a "Bond Terms
21 Agreement") providing the details and terms of the Series 2022C Bonds
22 in accordance with the authorizations provided herein and in a manner
23 consistent with the Special Revenue Bond Ordinance and this
24 Supplemental Ordinance. Such Bond Terms Agreements shall specify the
25 authorized amounts, details, terms and conditions of the Series 2022C
26 Bonds, including all other terms and provisions specified in Section
27 6.02 of the Special Revenue Bond Ordinance, may provide for the
28 creation of such funds, accounts and subaccounts, whether or not
29 within the funds and accounts established pursuant to the Special

1 Revenue Bond Ordinance, as shall be necessary or appropriate to
2 implement and administer the Series 2022C Bonds, including, without
3 limitation, remarketing proceeds and credit and liquidity facility
4 proceeds accounts and subaccounts, and may provide such revisions to
5 the form of the Bonds provided in Section 6.09 of the Special Revenue
6 Bond Ordinance as shall be appropriate to reflect the terms of the
7 Series 2022C Bonds. Such Bond Terms Agreements shall be in such form
8 as shall be approved by the Mayor upon the advice of the Chief
9 Financial Officer and the Office of General Counsel, execution and
10 delivery thereof to be conclusive evidence of such approval. Such
11 Bond Terms Agreements shall supplement the terms and provisions of
12 the Special Revenue Bond Ordinance and this Supplemental Ordinance
13 and shall be deemed to be part of the contract between the Issuer and
14 the Bondholders of the Series 2022C Bonds.

15 (b) The Mayor and Corporation Secretary are authorized to
16 execute and deliver such agreements and documents as shall be
17 necessary or appropriate to provide for the sale, issuance and
18 administration of each Series 2022C Bonds in a manner consistent with
19 the Special Revenue Bond Ordinance and the authorizations provided
20 in this Supplemental Ordinance, including, without limitation, Bond
21 Terms Agreements, commitment letters or agreements, bond purchase
22 agreements, remarketing agreements, escrow agreements, broker-dealer
23 agreements, registrar and paying agent agreements, credit and
24 liquidity facility reimbursement agreements, bond insurance and
25 Reserve Product agreements. Such documents and agreements shall be
26 in such form approved by the Mayor upon the advice of the Chief
27 Financial Officer and the Office of General Counsel, execution and
28 delivery thereof to be conclusive evidence of such approval.

1 **Section 15. Authorizations.**

2 (a) The Mayor and the Corporation Secretary or their duly
3 authorized alternative officers are hereby authorized and directed
4 on behalf of the Issuer to execute the Series 2022C Bonds (including
5 any temporary Series 2022C Bonds) as provided in the Special Revenue
6 Bond Ordinance and any of such officers is hereby authorized and
7 directed upon execution of the Series 2022C Bonds in substantially
8 the form provided herein (or in the applicable Bond Terms Agreement)
9 to deliver the Series 2022C Bonds in the amounts authorized hereunder
10 to the Deputy Registrar and Paying Agent for authentication and
11 delivery to or upon the order of one or more of the Approved
12 Underwriters or purchaser thereof upon payment of the purchase price
13 therefor.

14 (b) The Mayor, the Corporation Secretary of the Issuer, the
15 Chief Financial Officer and the General Counsel and such other
16 officers and employees of the Issuer as may be designated by the
17 Mayor are each designated as agents of the Issuer in connection with
18 the issuance and delivery of the Series 2022C Bonds and are authorized
19 and empowered, collectively and individually, to take all action and
20 steps, conduct such hearings, and to execute all instruments,
21 documents and contracts on behalf of the Issuer that are necessary
22 or desirable in connection with the financing and refinancing of the
23 Series 2022C Project and the sale, execution and delivery of the
24 Series 2022C Bonds and which are specifically authorized or are not
25 inconsistent with the terms and provisions of the Special Revenue
26 Bond Ordinance, this Supplemental Ordinance and the applicable Bond
27 Terms Agreement. Such officers and those so designated are hereby
28 charged with the responsibility for the issuance of the Series 2022C
29 Bonds and the financing and refinancing of the Series 2022C Project.

1 (c) It is the intent of the Council that the Special Revenue
2 Bond Ordinance and this Supplemental Ordinance (together with the
3 applicable Bond Terms Agreement) shall constitute full and complete
4 authorization and approval of the issuance of the Series 2022C Bonds
5 for the purposes and on the terms and conditions provided herein and
6 that no further action of the Council shall be required with respect
7 thereto.

8 **Section 16. Waiver of Section 104.211, Ordinance Code,**
9 **Authorized.** The provisions of Section 104.211 (Procedure for Sale
10 of Bonds) of Chapter 104 (Bonds), *Ordinance Code*, are hereby waived
11 so as to allow for the Issuer to award the sale of the Series 2022C
12 Bonds on a limited competitive basis, on a negotiated basis or as a
13 private placement to institutional investors rather than on a
14 competitive basis. This waiver is necessary because of the need for
15 flexibility in timing the issuance and sale of the Series 2022C Bonds,
16 the need to allow for a timely sale of the Series 2022C Bonds together
17 with other refunding Special Revenue Bonds, advantages expected to
18 be received from an enhanced marketing of the Series 2022C Bonds
19 afforded by engaging one or more investment banking firms in a limited
20 competitive sale, a negotiated sale, or a private placement to
21 institutional investors, and in consultation with the Chief Financial
22 Officer and the Issuer's Financial Advisor.

23 **Section 17. Effective Date.** This Supplemental Ordinance shall
24 become effective upon signature by the Mayor or upon becoming
25 effective without the Mayor's signature.
