- Created segregated debt service and debt service reserve investment accounts to custody the assets used to ensure the City's bonds make timely payments separately from other operating funds, a best practice recommendation of the IRS.
- Member of the leadership team spearheading various special projects including, but not limited to, reform of the City's pension plans, contract negotiations, legal reviews, implementation of software systems, closure of the Better Jacksonville Program, and bank implementation.
