5 AN ORDINANCE APPROPRIATING \$200,000 FROM THE  
6 SPECIAL COUNCIL OPERATING CONTINGENCY  
7 ESTABLISHED BY ORDINANCE 2022-317-E TO THE  
8 PUBLIC SERVICE GRANT MICRO-GRANT PROGRAM TO FUND  
9 THE PSG MICRO-GRANT PROGRAM FOR PRIORITY  
10 POPULATIONS, AS APPROVED BY ORDINANCE 2022-214-  
11 E; PROVIDING FOR OVERSIGHT; PROVIDING FOR  
12 CARRYOVER; PROVIDING AN EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1.** For the 2021-2022 fiscal year, within the City's  
16 budget, there are hereby appropriated the indicated sum(s) from the  
17 account(s) listed in subsection (a) to the account(s) listed in  
18 subsection (b):

25 (c) Explanation of Appropriation

26 The appropriation above provides \$200,000 from the Special  
27 Council Operating Contingency established by Ordinance  
28 2022-317-E to fund the PSG Micro-Grant Pilot Program that  
29 was included as one of the priority populations approved  
30 by Ordinance 2022-214-E.

31 **Section 2. Purpose.** The purpose of the appropriation in

1 Section 1 is to provide funding to the Public Service Grant Council  
2 to fund the Micro-Grant Pilot Program established in the 2022-2023  
3 Most Vulnerable Persons and Needs category through Ordinance 2022-  
4 214-E. It was established in Ordinance 2022-214-E that funding for  
5 the Micro-Grant Pilot Program would be in separate legislation.

6 **Section 3. Oversight Department.** The Office of Grants and  
7 Contract Compliance of the Finance and Administration Department  
8 shall oversee the project described herein.

9 **Section 4. Carryover.** The funds appropriated in this  
10 Ordinance shall not lapse but shall carryover to fiscal year 2022-  
11 2023.

12 **Section 5. Effective Date.** This ordinance shall become  
13 effective upon signature by the Mayor or upon becoming effective  
14 without the Mayor's signature.
