ORDINANCE 2022-488-E

A READOPTION OF PRELIMINARY RATE AND ANNUAL ASSESSMENT ORDINANCE PURSUANT TO CHAPTER 197, FLORIDA STATUTES, AND CHAPTER 715, ORDINANCE FOR SPECIAL ASSESSMENTS IN DOWNTOWN JACKSONVILLE PURSUANT TO ORDINANCE 2021-292-E; IDENTIFYING THE SERVICES PROVIDED; INCLUDING THE SERVICE COST; ESTABLISHING THE 2022 ASSESSMENT RATE; SCHEDULING THE PUBLIC HEARINGS; PROVIDING NOTICE BY PUBLICATION AND MAILING; APPROVING THE 2022 FINAL ASSESSMENT ROLL AND METHOD OF COLLECTION; RETAINING RIGHTS UNDER CHAPTERS 170 197, FLORIDA STATUTES; PROVIDING AN AND EFFECTIVE DATE.

WHEREAS, by Resolution 2021-03-03, the Downtown Investment Authority approved the expansion of the Downtown Business Improvement District, originally created by the City Council in 1999, and approved expansion of the classes of properties subject to a special assessment within the Downtown Business Improvement District; and

WHEREAS, for over 20 years, Downtown Vision, Inc., has provided enhanced municipal services in Downtown Jacksonville, which advance the City's redevelopment goals and benefit the assessed properties in Downtown; and

WHEREAS, City of Jacksonville Ordinance 2021-292-E authorized annual assessments for properties located within the service area; and

WHEREAS, annual assessments must be approved by Council through a Final Assessment Roll procedure for the use of the uniform method; and

WHEREAS, the preliminary rate has not changed from prior year and use of a single piece of legislation as the preliminary rate ordinance and final roll ordinance is consistent with the state statutes and is not contrary to public interest; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Incorporating the recitals. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance upon adoption thereof.

Section 2. Services to be provided. The services to be provided were included in ordinance 2021-292-E, and will continue to include stabilizing and improving the service area through promotion, management, marketing and other similar services as further defined in the Enhanced Municipal Services Agreement, attached hereto as Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev Agmt, August 2, 2022 - Finance" and incorporated herein by reference.

Section 3. Service Cost. The total estimated revenue to be collected or service cost is included in the Enhanced Municipal Services Agreement, attached hereto as Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev Agmt, August 2, 2022 - Finance".

Section 4. Assessment Rate. Pursuant to Section 197.3632, Florida Statutes, and Section 715.208, Ordinance Code, the special assessment rate shall be equal to the value of 1.1 mills on each property. The term of this special assessment shall be from the 2022 Tax Year through the 2031 Tax Year.

Section 5. Public Hearing. The Council held public hearings on July 26, 2022 and August 9, 2022, to hear testimony from affected property owners as to the propriety and advisability of funding the

proposed improvements previously described in Initial Assessment Ordinance 2021-292-E which authorizes annual special assessments on property as described therein, and met as an equalizing board to hear and consider any and all complaints as to the special assessments. The Council hereby confirms the Initial Assessment Ordinance 2021-292-E, approves the 2022 preliminary rate set forth herein, and approves continuing the assessment rate as established in Initial Assessment Ordinance 2021-292-E for the 2022 assessment.

Section 6. Notice. Proof of first class mailing of the notices required by Section 197.3632, Florida Statutes, and Section 715.205, Ordinance Code, is attached hereto as Exhibit 2. In accordance with Section 197.3632, Florida Statutes, notices for previously assessed properties shall be provided through the Property Appraiser's notice of property taxes under Section 200.069, Florida Statutes. Notice has also been provided via publication pursuant to the requirements of Section 197.3632, Florida Statutes, is attached hereto as Exhibit 3.

Section 7. Final Assessment Roll and Method of Collection.

The Council hereby approves the 2022 Final Assessment Roll attached hereto as Exhibit 4. The method of collection for 2022 shall be the uniform method pursuant to Chapter 197, Florida Statutes.

Section 8. Retaining All Rights Granted by Chapter 170 and 197, Florida Statutes. The City of Jacksonville hereby retains all rights granted to municipalities by Chapters 170 and 197, Florida Statutes, for the special assessments authorized herein, including priority of lien, interest and foreclosure; provided, however, that any legal proceeding to enforce payment of such special assessments shall require City Council approval.

Section 9. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
