7 AN ORDINANCE CONCERNING THE CREATION OF AN
8 ADMINISTRATOR POSITION TO SUPPORT THE WORK OF
9 THE DUVAL COUNTY TOURIST DEVELOPMENT COUNCIL
10 ("TDC") AND ITS EXECUTIVE DIRECTOR;
11 APPROPRIATING \$13,823.00 FROM TOURIST
12 DEVELOPMENT COUNCIL FUND BALANCE TO PROVIDE
13 FUNDING FOR SUCH POSITION; PURPOSE OF
14 APPROPRIATION; APPROVING THE POSITION, AS
15 INITIATED BY R.C. 22-164; REQUESTING ONE CYCLE
16 EMERGENCY PASSAGE; PROVIDING FOR AN EFFECTIVE
17 DATE.

20 **WHEREAS**, the TDC has identified a need to create and hire the
21 job position of administrator to support the work of the TDC and its
22 executive director as authorized under Section 70.103(d), *Ordinance*
23 *Code*; and

24 **WHEREAS**, at its meeting on June 30, 2022, the TDC approved the
25 creation of this position; now therefore,

26 **BE IT ORDAINED** by the Council of the City of Jacksonville:

27 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
28 within the City's budget, there is hereby appropriated the indicated
29 sum from the account listed in subsection (a) to the account listed
30 in subsection (b):

2 incorporated herein by this reference):

7 (c) Explanation of Appropriation.

8 This ordinance appropriates \$13,823 from Tourist
9 Development Council fund balance to the TDC Administration
10 activity to provide funding for the salaries, benefits,
11 and office expenses of the administrator position through
12 September 30, 2022.

13 **Section 2. Purpose.** The purpose of the appropriation in
14 Section 1 is to provide funding for the creation of the job position
15 of administrator in order to provide administrative and office support
16 to the TDC and its executive director.

17 **Section 3. Approval of Position.** There is hereby
18 approved the position more fully described in R.C. 22-164, attached
19 hereto as **Exhibit 2** and incorporated herein by this reference.

20 **Section 4. Requesting emergency one cycle passage pursuant**
21 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
22 legislation is requested. The nature of the emergency is that the
23 appropriation is needed in order to fill the administrator position
24 as soon as possible.

25 **Section 5. Effective Date.** This Ordinance shall become
26 effective upon signature by the Mayor or upon becoming effective
27 without the Mayor's signature.
