1 Introduced by Council President Newby at the request of the 2 Construction Trades Qualifying Board: 3 4 ORDINANCE 2022-653 5 AN ORDINANCE CONCERNING THE CONSTRUCTION TRADES 6 7 OUALIFYING BOARD; AMENDING SECTION 62.107 8 (MEETINGS), CHAPTER 62 (CONSTRUCTION TRADES QUALIFYING BOARD), ORDINANCE CODE, TO REDUCE THE 9 NUMBER OF BOARD MEMBERS NECESSARY FOR A QUORUM; 10 11 PROVIDING FOR CODIFICATION INSTRUCTIONS; PROVIDING AN EFFECTIVE DATE. 12 13 WHEREAS, pursuant to Section 3.106 (Method of introduction of 14 15 certain legislation) and Section 62.106 (Powers and Duties), Ordinance 16 Code, the Construction Trades Qualifying Board (the "Board") may 17 recommend to City Council amendments to Chapter 62 (Construction Trades 18 Qualifying Board), Ordinance Code; and 19 WHEREAS, the Board desires to amend Chapter 62 to reduce the quorum 20 requirement to more effectively carry out its powers and duties under 21 Chapter 62; and 22 WHEREAS, the Board at its regular meeting on August 3, 2022, 23 unanimously approved recommending to City Council an amendment to Chapter 24 62 to reduce the quorum requirement; now therefore BE IT ORDAINED by the Council of the City of Jacksonville: 25 26 Section 1. **Recitals.** The recitals set forth above are true 27 and correct and incorporated herein by reference. 28 Section 2. Amending Section 62.103 (Meetings), Chapter 62 29 (Construction Trades Qualifying Board), Ordinance Code. Section 62.103 (Meetings), Chapter 62 (Construction Trades Qualifying Board), 30 Ordinance Code, is hereby amended to read as follows: 31

CHAPTER 62. - CONSTRUCTION TRADES QUALIFYING BOARD

* * *

Sec. 62.103. - Meetings.

The Board shall hold at least four meetings each fiscal year, one 4 each in October, January, April and July. Regular or special 5 meetings shall be called by the chairman of the Board and in his 6 7 absence by the vice-chairman of the Board or by a quorum of the Board. Special meetings shall be called only with at least forty-8 9 eight hours' notice to all members as to the time and place. A 10 quorum shall consist of nine members the greater of five members or a third of the current Board membership. Vacant board seats 11 shall not be included in the quorum determination. An affirmative 12 vote shall consist of a simple majority of the members present. 13

15 Section 3. Codification Instructions. The Codifier and the 16 Office of General Counsel are authorized to make all chapter and 17 division "tables of contents" consistent with the changes set forth 18 herein. Such editorial changes and any others necessary to make the 19 Ordinance Code consistent with the intent of this legislation are 20 approved and directed herein, and the changes to the Ordinance Code 21 shall be made forthwith and when inconsistencies are discovered.

22 Section 4. Effective Date. This Ordinance shall become 23 effective upon signature by the Mayor or upon becoming effective 24 without the Mayor's signature.
