The TDC has identified Visit Jacksonville, by virtue of its employees, leadership and experience, as uniquely and strongly positioned to serve the tourism interests of the City of Jacksonville for the foreseeable future and desires to cement an extended relationship with Visit Jacksonville, as evident by the TDC unanimously approving a direct contract with Visit Jacksonville at their February 24, 2022 meeting, to provide stability to the parties as they implement a long-term tourism strategy that benefits the City of Jacksonville and its citizens.";
