4 **ORDINANCE 2022-560-E**

5 AN ORDINANCE APPROVING, AND AUTHORIZING THE
6 MAYOR AND CORPORATION SECRETARY TO EXECUTE AND
7 DELIVER, AN AMENDMENT THREE TO ECONOMIC
8 DEVELOPMENT AGREEMENT BETWEEN THE CITY OF
9 JACKSONVILLE AND AA AUTO PARTS, INC. ("COMPANY")
10 TO EXTEND THE COMPLETION OF CONSTRUCTION DATE
11 FROM JUNE 30, 2022 TO DECEMBER 31, 2022;
12 PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, the City and AA Auto Parts, Inc. have previously entered
15 into that certain Economic Development Agreement dated November 22,
16 2019 (the "Agreement"), as authorized by Ordinance 2019-652-E,
17 pursuant to which the City agreed to provide a \$150,000 Northwest
18 Jacksonville Economic Development Fund ("NWJEDF") Loan and a \$100,000
19 NWJEDF Business Infrastructure Grant ("BIG") in support of the
20 additional infrastructure and site improvements needed to support the
21 installation of a metal shredder system at the Company's existing
22 facility (the "Project"); and

23 **WHEREAS**, as authorized by Section 12.6 of the Agreement, the
24 Agreement has been amended twice to extend the Project completion
25 date from July 1, 2021 to December 31, 2021, and then from December
26 31, 2021 to June 30, 2022, with no further administrative authority
27 to extend the performance schedule of the Agreement; and

28 **WHEREAS**, the Project has experienced further unanticipated
29 delays due to supply chain interruptions and labor shortages resulting

1 from the COVID-19 pandemic, and the Company has requested, and the
2 City has agreed, subject to City Council approval, to amend the
3 Agreement to extend the completion of construction date from June 30,
4 2022 to December 31, 2022, so that the Company may remain eligible
5 for the NWJEDF Loan and NWJEDF BIG; now therefore

6 **BE IT ORDAINED** by the Council of the City of Jacksonville:

7 **Section 1. Amendment Three to Economic Development**
8 **Agreement approved and execution authorized.** There is hereby
9 approved, and the Mayor and Corporation Secretary are hereby
10 authorized to execute and deliver, Amendment Three to Economic
11 Development Agreement between the City of Jacksonville and AA Auto
12 Parts, Inc., in substantially the form attached hereto as **Exhibit 1**
13 and incorporated herein by this reference ("Amendment Three").
14 Amendment Three amends the Economic Development Agreement by
15 extending the completion of construction date by an additional six
16 months.

17 **Section 2. Effective Date.** This ordinance shall become
18 effective upon signature by the Mayor or upon becoming effective
19 without the Mayor's signature.
