6 AN ORDINANCE APPROPRIATING GRANT FUNDS IN THE  
7 AMOUNT OF \$229,148.25 FROM THE U.S. DEPARTMENT  
8 OF JUSTICE, BUREAU OF JUSTICE ASSISTANCE,  
9 THROUGH THE STATE ATTORNEY'S OFFICE, FOURTH  
10 JUDICIAL CIRCUIT OF FLORIDA, FOR THE FISCAL  
11 YEAR 2021 NATIONAL SEXUAL ASSAULT KIT  
12 INITIATIVE (SAKI), TO FUND ONE FULL-TIME  
13 PUBLIC SAFETY ANALYST POSITION, INCLUDING THE  
14 PURCHASE OF NECESSARY EQUIPMENT AND SOFTWARE  
15 FOR SAID POSITION, AS INITIATED BY B.T. 22-  
16 082; APPROVING ONE PUBLIC SAFETY ANALYST  
17 POSITION, AS INITIATED BY R.C. 22-131;  
18 APPROVING, AND AUTHORIZING THE MAYOR, OR HIS  
19 DESIGNEE, AND THE CORPORATION SECRETARY TO  
20 EXECUTE AND DELIVER THAT CERTAIN SUBCONTRACT  
21 BETWEEN THE STATE ATTORNEY'S OFFICE, 4TH  
22 JUDICIAL CIRCUIT, AND THE JACKSONVILLE  
23 SHERIFF'S OFFICE, FOR THE FISCAL YEAR 2021  
24 NATIONAL SEXUAL ASSAULT KIT INITIATIVE;  
25 PROVIDING FOR CITY OVERSIGHT BY THE  
26 JACKSONVILLE SHERIFF'S OFFICE, INVESTIGATIONS  
27 AND HOMELAND SECURITY DIVISION; PROVIDING AN  
28 EFFECTIVE DATE.

30 **BE IT ORDAINED** by the Council of the City of Jacksonville:

31 **Section 1. Appropriation.** For the 2021-2022 fiscal year,

1 within the City's budget, there is hereby appropriated the  
2 indicated sum(s) from the account(s) listed in subsection (a) to  
3 the account(s) listed in subsection (b):

10 (c) Explanation of Appropriation

11 The funding above is a grant from the U.S. Department of  
12 Justice, Bureau of Justice Assistance, through the State  
13 Attorney's Office, Fourth Judicial Circuit of Florida,  
14 under the Fiscal Year 2021 National Sexual Assault  
15 Initiative (SAKI). The grant period commences on the  
16 date of execution of the subcontract with the State  
17 Attorney's Office, Fourth Judicial Circuit, and continues  
18 through September 30, 2024. No local match is required.

19 **Section 2. Purpose.** The purpose of the appropriation in  
20 Section 1 is to pay the salary and benefits of one full-time Public  
21 Safety Analyst position who will work exclusively on the SAKI  
22 project. The SAKI project seeks to reduce the number of  
23 unsubmitted sexual assault kits held in evidence, supports the  
24 investigation and prosecution of sexual assault cases, provides  
25 services to the victims, and examines policies that led to the  
26 creation of the unsubmitted kit inventory. The Public Safety  
27 Analyst position paid for by this grant will perform crime analyses  
28 to identify patterns, trends and evidence for the prosecution of  
29 sexual assault cases. Grant funds will also be used to procure  
30 equipment and software needed for this position.

31 **Section 3. Approval of Position.** There is hereby

1 approved the position more fully described in R.C. 22-131, attached  
2 hereto as **Exhibit 2** and incorporated herein by this reference.

3 **Section 4. Agreement Approved and Execution Authorized.**

4 There is hereby approved, and the Mayor, or his designee, and the  
5 Corporation Secretary are hereby authorized to execute and deliver,  
6 for and on behalf of the City, that certain Subcontract between the  
7 State Attorney's Office, 4<sup>th</sup> Judicial Circuit, and the Jacksonville  
8 Sheriff's Office, in substantially the form placed **On File** with the  
9 Office of Legislative Services.

10 **Section 5. Oversight.** The Jacksonville Sheriff's Office,

11 Investigations and Homeland Security Division, shall oversee the  
12 grant described herein.

13 **Section 6. Effective Date.** This Ordinance shall become

14 effective upon signature by the Mayor or upon becoming effective  
15 without the Mayor's signature.
