AN ORDINANCE GRANTING ADMINISTRATIVE DEVIATION APPLICATION AD-22-65, FOR PROPERTY LOCATED IN COUNCIL DISTRICT 2 AT 15221 NORTH MAIN STREET, 15225 NORTH MAIN STREET, 15239 NORTH MAIN STREET, 15249 NORTH MAIN STREET AND 15311 NORTH MAIN STREET, BETWEEN KIRK ROAD AND BIRD ROAD (R.E. NOS. 108284-0000, 108284-0500, 108287-0000, 108288-0000 AND 108290-0100), AS DESCRIBED HEREIN, OWNED BY MARK MOORE, AS TRUSTEE OF THE MAIN LAND TRUST DATED NOVEMBER 21, 2014, JACQUELINE UPTON, KAYLA ANN BREEDING, DONNETTE CHRISTINE WILLIAMS, KAREN LYNN BECK, MAIN OBJECTIVE B LLC, AND MAIN OBJECTIVE A LLC, REQUESTING TO DECREASE THE MINIMUM NUMBER OF LOADING SPACES FROM FIVE TO ZERO FOR FIVE LOTS IN CURRENT ZONING DISTRICTS COMMERCIAL COMMUNITY/GENERAL-2 (CCG-2) DISTRICT, RESIDENTIAL LOW DENSITY-100A (RLD-100A) DISTRICT AND PLANNED UNIT DEVELOPMENT (PUD) DISTRICT (2009-141-E)/PROPOSED ZONING DISTRICT RESIDENTIAL MEDIUM DENSITY-D (RMD-D), AS DEFINED AND CLASSIFIED UNDER THE ZONING CODE; ADOPTING RECOMMENDED FINDINGS AND CONCLUSIONS OF THE LAND USE AND ZONING COMMITTEE; PROVIDING FOR DISTRIBUTION; PROVIDING AN EFFECTIVE DATE.

with the City Council Legislative Services Division, was filed by Cyndy Trimmer, Esq., on behalf of the owners of property located in Council District 2 at 15221 North Main Street, 15225 North Main Street, 15239 North Main Street, 15249 North Main Street and 15311 North Main Street, between Kirk Road and Bird Road (R.E. Nos. 108284-0000, 108284-0500, 108287-0000, 108288-0000 and 108290-0100) (the "Subject Property"), requesting to decrease the minimum number of loading spaces from five to zero for five lots in current Zoning Districts Commercial Community/General-2 (CCG-2) District, Residential Low Density-100A (RLD-100A) District and Planned Unit Development (PUD) District (2009-141-E)/proposed Zoning District Residential Medium Density-D (RMD-D); and

WHEREAS, the Planning and Development Department has considered the application and all attachments thereto and has rendered an advisory recommendation; and

WHEREAS, the Land Use and Zoning Committee, after due notice held a public hearing and having duly considered both the testimonial and documentary evidence presented at the public hearing, has made its recommendation to the Council; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville: Section 1. Adoption of Findings and Conclusions. Council has considered the recommendation of the Land Use and Zoning Committee and reviewed the Staff Report of the Planning Development Department concerning administrative Application AD-22-65, which requests to decrease the minimum number of loading spaces from five to zero for five lots. Based upon the competent, substantial evidence contained in the record, the Council hereby determines that the requested administrative deviation meets each of the following criteria required to grant the request pursuant to Section 656.109(h), Ordinance Code, as specifically identified in the Staff Report of the Planning and Development Department:

(1) There are practical or economic difficulties in carrying out the strict letter of the regulation;

- (2) The request is not based exclusively upon a desire to reduce the cost of developing the site, but would accomplish some result that is in the public interest, such as, for example, furthering the preservation of natural resources by saving a tree or trees;
- (3) The proposed deviation will not substantially diminish property values in, nor alter the essential character of, the area surrounding the site and will not substantially interfere with or injure the rights of others whose property would be affected by the deviation;
- (4) The proposed deviation will not be detrimental to the public health, safety or welfare, result in additional public expense, the creation of nuisances, or conflict with any other applicable law;
- (5) The proposed deviation has been recommended by a City landscape architect, if the deviation is to reduce required landscaping; and
- (6) The effect of the proposed deviation is in harmony with the spirit and intent of the Zoning Code.

Therefore, administrative deviation Application AD-22-65 is hereby approved.

Section 2. Owner and Description. The Subject Property is owned by Mark Moore, as Trustee of the Main Land Trust dated November 21, 2014, Jacqueline Upton, Kayla Ann Breeding, Donnette Christine Williams, Karen Lynn Beck, Main Objective B LLC, and Main Objective A LLC, and is described in Exhibit 1, dated July 21, 2022, and graphically depicted in Exhibit 2, both attached hereto. The applicant is Cyndy Trimmer, Esq., 1 Independent Drive, Suite 1200, Jacksonville, Florida 32202; (904) 807-0185.

Section 3. Distribution by Legislative Services.

Legislative Services is hereby directed to mail a copy of this

Section 4. Effective Date. The enactment of this Ordinance shall be deemed to constitute a quasi-judicial action of the City Council and shall become effective upon signature by the Council President and Council Secretary.
