A RESOLUTION HONORING THE LIFE AND MOURNING THE PASSING OF DEBORAH MOSLEY NORMAN; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Deborah Mosley Norman was born and raised Jacksonville and was a proud graduate of Matthew W. Gilbert High School; and

WHEREAS, Mrs. Norman attended Florida Memorial University where she was Vice President of Alpha Kappa Mu Honor Society and secretary of Zeta Phi Beta Sorority. She later graduated Magna Cum Laude from FMU and received the D.W. Perkins Award for the highest average in Social Studies and was listed in Who's Who in Colleges and Universities; and

WHEREAS, Mrs. Norman knew after graduation that her life's work would revolve around helping the youth in her community, so she went on to attend Purdue University and earned a Master of Science degree in Guidance and Counseling; and

WHEREAS, after graduate school, Deborah Norman returned to Jacksonville to teach at her alma mater Matthew W. Gilbert High School, where she was honored to receive the "Young Teacher's Achievement Award" from fellow faculty. She later followed her calling to become a High School Guidance Counselor and served as Director of Guidance Services for William Raines High School for thirty-five years; and

WHEREAS, Mrs. Norman was instrumental in securing millions of

dollars in scholarships for the talented Raines Graduates; and

WHEREAS, Deborah Norman received numerous honors over the years, such as the "Guidance Counselor of the Year Award" from the INROADS Organization of Jacksonville, the Raines "The Most Valuable Teacher Award", the Raines High Golden Support Award, the Raines Legend Award, the Dedicated Community Advocate Award from the Jacksonville City Council, and the Humanitarian Award from the Matthew W. Gilbert Grand Reunion Alumni Association; in 2019 the Guidance Suite at William M. Raines High School was renamed in her honor, and in 2020 Mrs. Norman was the first recipient of the Jacksonville Image Education Excellence Award; and

WHEREAS, Mrs. Norman was a woman of strong faith, and was a pillar member of the First Baptist Church of Oakland on Eastside who worked with several major youth ministries at the church. She was a member of Leadership Jacksonville, volunteered as a Big Sister for the Big Brothers Big Sisters organization, and influenced young people in the community with the I'm A Star Foundation; and

WHEREAS, Deborah Norman was a loving wife to her husband Ervin Norman for 52 years, a devoted mother to her daughter Nicole, a sister, cousin and a dear friend to so many. She was a valued mentor to her colleagues and a beacon of light to countless students and youth in our city, believing that every student has potential and should be given the opportunity to triumph; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. The City of Jacksonville hereby honors the life and service of Deborah Norman, with appreciation for the decades she dedicated to helping the youth in our community become all that they could be.
