AN ORDINANCE APPROVING, AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE AND DELIVER THAT CERTAIN LICENSE AGREEMENT BETWEEN THE CITY OF JACKSONVILLE (LANDLORD) AND **JACKSONVILLE** MOTORCYCLE SAFETY TRAINING, INC. (TENANT), SAID LICENSE BEING FOR AN INITIAL TERM OF ONE (1) YEAR, WITH TWO (2) ONE (1) YEAR RENEWAL OPTIONS, FOR THE USE OF CIRCLE B PARKING LOT IN CECIL COMMERCE CENTER, LOCATED GENERALLY AT INTERSECTION OF LAKE NEWMAN STREET AND MCCARTHY WAY, JACKSONVILLE, FLORIDA, WITH A MONTHLY BASE RENT OF \$200 PER MONTH; PROVIDING FOR OVERSIGHT BY THE OFFICE OF ECONOMIC DEVELOPMENT; PROVIDING AN EFFECTIVE DATE.

("Tenant"), in substantially the same form placed On File with the Office of Legislative Services (the "License"), and any amendment exercising a renewal option to extend the term of the License for each renewal period and based on the rental schedule provided in the License. Said License is for a term of one (1) year,
