Section 3. Purpose. The purpose of the appropriation in Section 1 is to provide additional funds for the Duval County Adult The funding will be used to expand the Drug Court program. collaborative delivery system of population focused care between the Courts and local community-based care agencies. The funds will allow the Courts to implement evidence-based treatment modalities to 40 unduplicated participants annually, with a goal of serving 200 participants during the five-year grant period. In addition, funding will be used to increase available bed days for adult residential treatment, increase the use of medication-assisted treatment, and provide random, observed drug and alcohol testing. Intense substance abuse/mental health treatment services and case management will also be provided with various support services. Staffing will be provided through current staff members. A copy of the Notice of Award is attached hereto as Exhibit 2 and incorporated herein by this reference.

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
