THE APPLICANT OPERATES UNDER A ZONING EXCEPTION UNDER SECTION 656.313, A.IV(C)(8), WHICH LIMITS INVENTORY TO ITEMS PERMITTED IN THE CCG-1 ZONING DISTRICT AND PROVIDED THAT NO OUTSIDE STORAGE OR DISPLAY OF PRODUCTS IS ALLOWED. THE APPLICANT WOULD CONTINUE TO COMPLY WITH THE CITYS LAND DEVELOPMENT CODE.


