5 AN ORDINANCE APPROPRIATING \$857,148.42 FROM THE
6 MCCOYS CREEK LELAND STREET BRIDGE REMOVAL
7 PROJECT TO THE MCCOYS CREEK CHANNEL
8 IMPROVEMENTS/RESTORATION PROJECT (THE
9 "PROJECT") TO PAY FOR CONSTRUCTION ENGINEERING
10 AND INSPECTION SERVICES FOR THE PROJECT, AS
11 INITIATED BY B.T. 22-117; AMENDING THE 2023-2027
12 FIVE-YEAR CAPITAL IMPROVEMENT PLAN APPROVED BY
13 ORDINANCE 2022-505-E TO REFLECT THIS
14 APPROPRIATION OF FUNDS TO THE PROJECT; PROVIDING
15 AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Appropriation.** For the 2022-2023 fiscal year,
19 within the City's budget, there is hereby appropriated the indicated
20 sum(s) from the account(s) listed in subsection (a) to the account(s)
21 listed in subsection (b):

29 The funding above represents an appropriation of
30 \$857,148.42 from the completed McCoys Creek Leland Street
31 Bridge Removal project to the McCoys Creek Channel

1 Improvements/Restoration project to procure professional
2 services.

3 **Section 2. Purpose.** The purpose of the appropriation in
4 Section 1 is to allocate additional funds to the McCoys Creek Channel
5 Improvements/Restoration project (the "Project") to pay for
6 construction engineering and inspection services. These services are
7 integral to successful completion of the Project.

8 **Section 3. Capital Improvement Plan Amendment.** Ordinance
9 2022-505-E, adopting the 2023-2027 Five-Year Capital Improvement Plan
10 (the "CIP") for the City and certain of its independent agencies, is
11 hereby amended to provide additional funding for the McCoys Creek
12 Channel Improvements/Restoration project as more fully described in
13 the Project Information Sheets attached hereto as **Exhibit 2** and
14 incorporated herein by this reference. The City Council finds that
15 the deferral of this amendment of the CIP until the next annual budget
16 and CIP review will be detrimental to the best interests of the
17 community because such deferral will unnecessarily delay completion
18 of the Project.

19 Pursuant to Section 122.605(c), *Ordinance Code*, enactment of
20 this Ordinance requires the affirmative vote of two-thirds of the
21 City Council members present at the meeting because of the CIP
22 amendment set forth in this section. This Ordinance shall constitute
23 an amendment to Ordinance 2022-505-E. In all other respects, the
24 Five-Year Capital Improvement Plan approved by Ordinance 2022-505-E
25 shall remain unchanged and continue in full force and effect.

26 **Section 4. Effective Date.** This Ordinance shall become
27 effective upon signature by the Mayor or upon becoming effective
28 without the Mayor's signature.
