2 Section 2. Purpose. The purpose of the appropriation in 3 Section 1 is to fund six DPRP loans in the aggregate amount of \$8,624,320 to JWB Real Estate Capital, LLC ("Developer") as the 4 borrower, pursuant to that certain Redevelopment Agreement between 5 the Downtown Investment Authority ("DIA") and the Developer, dated 6 January 20, 2021 ("RDA"), as previously authorized by Ordinance 2021-7 332-E. Substantial completion of the improvements as set forth in the 8 9 RDA is anticipated in the current City fiscal year and the DPRP loan funds are then disbursed pursuant to the RDA. 10

11 Section 3. Reverter. Any remaining funds after the 12 substantial completion of the improvements and disbursement of the 13 DPRP Loans as set forth in the RDA shall be returned to the account 14 of origin.
