ORDINANCE 2022-907

AN ORDINANCE APPROVING AND ADOPTING A NEW PILOT PROGRAM ENTITLED "FOOD WASTE DIVERSION (COMPOSTING) PILOT PROGRAM" (THE "PILOT PROGRAM") TO PROVIDE A VOLUNTARY OPPORTUNITY FOR DUVAL COUNTY PUBLIC SCHOOLS AND VARIOUS FOOD-BASED BUSINESSES IN THE RIVERSIDE-AVONDALE AREA TO PARTNER WITH THE CITY OF JACKSONVILLE FOR THE PROVISION OF LIMITED COMPOSTING SERVICES FOR CERTAIN FOOD PRODUCTS; PROVIDING FOR A SUNSETTING OF THE PILOT PROGRAM UNLESS EXTENDED BY LEGISLATION; CREATING A FOOD WASTE DIVERSION PROGRAM SPECIAL REVENUE FUND INTO WHICH FUNDS COLLECTED FROM THE PILOT PROGRAM SHALL BE DEPOSITED FOR USE AS PROVIDED HEREIN; APPROVING AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER A CONTRACT BETWEEN THE CITY OF JACKSONVILLE AND SUNSHINE ORGANICS & COMPOST LLC TO IMPLEMENT THE PILOT PROGRAM; PROVIDING FOR CITY OVERSIGHT OF THE PILOT PROGRAM BY THE SOLID WASTE DIVISION OF THE PUBLIC WORKS DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on average, Americans waste around 25% of all food purchases each year, which has led to increases in landfill waste by the tons;

WHEREAS, the City of Jacksonville (the "City") recognizes the need to reduce the amount of solid waste entering its landfills to protect the public health, safety, and welfare of City residents, visitors, and future generations;

WHEREAS, the City finds that a composting pilot program will encourage the diversion of solid waste from entering landfills while also benefitting businesses who participate in the program through cost savings that would be realized from reduced hauling fees that are paid to cover trash collection; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Approval and Adoption of the "Food Waste Diversion (Composting) Pilot Program." There is hereby approved and adopted within the City a "Food Waste Diversion (Composting) Pilot Program" (the "Pilot Program"), which will provide a voluntary opportunity for food-based businesses to partner with the City and its contractor, Sunshine Organics & Compost LLC ("Contractor"), to provide an opportunity for limited composting services to various restaurants and food-based businesses in the Riverside/Avondale area and nearby farmer's markets as well as the Duval County Public Schools Nutrition Service Center ("NSC") facility. The City and the Contractor will administer the Pilot Program in accordance with the terms and conditions of that certain Contract Between the City of Jacksonville and Sunshine Organics & Compost LLC for the Food Waste (Composting) Pilot Program (the "Contract"), substantially the form placed **On File** with the Legislative Services Division. Pursuant to the Contract, the Contractor shall invoice each participating facility at a rate of \$25.00 per bin collected in addition to a "tipping fee" assessed based on the weight of material collected, with the exception that any participating Duval County Public Schools facilities shall not be charged any fees or costs for participating in the Pilot Program. The Contractor will remit to the

City all fees collected from participating facilities of the Pilot Program to be deposited in the City's Food Waste Diversion Special Revenue Fund established by this Ordinance. The "Food Waste Diversion (Composting) Pilot Program" will commence on February 15, 2023 and will continue through June 30, 2023. The Solid Waste Division of the Public Works Department shall submit a preliminary report to the Council on or before July 31, 2023, outlining the total funds collected from the Pilot Program, summarizing the successes and opportunities for improvement realized from the Pilot Program, including any recommendations the Public Works Department may have with regards to initiating a permanent composting program for the City, and to any other information or recommendations the Council may request relative to the Pilot Program.

Section 2. Sunset of Pilot Program. The provisions of this Ordinance providing for the "Food Waste Diversion (Composting) Pilot Program" as described in Section 1, shall sunset, be repealed, and be of no further effect on June 30, 2023, unless extended by subsequent legislation.

Revenue Fund. There is hereby created a special revenue fund of the City to be known as the "Food Waste Diversion Program Special Revenue Fund", hereinafter called the "Fund". The Fund shall contain the monies remitted by Sunshine Organics & Compost LLC, that are derived from the fees collected from participants of the City's Food Waste Diversion (Composting) Pilot Program. The monies deposited in the Fund shall remain in the Fund for the duration of the Pilot Program with the intent that such monies will be used toward establishment of a permanent composting program for the City or to cover costs arising from any extension of the Pilot Program, subject to Council appropriation for such purposes. In the event the Pilot Program is not extended, or a permanent composting program is not established

by Council on or before October 1, 2023, 50% of the monies held in the Fund will be remitted to Sunshine Organics & Compost LLC, with the remaining 50% being retained by the City to be used toward expenses incurred in administering the Pilot Program. Monies deposited in the Fund, together with any interest accrued thereon, shall not lapse at the end of any fiscal year and shall carry forward to subsequent fiscal years.

Section 4. Approval and Authorization to Execute Contract.

There is hereby approved, and the Mayor, or his designee, and Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City, that certain Contract between the City of Jacksonville and Sunshine Organics & Compost LLC for the Food Waste Diversion (Composting) Pilot Program, outlining the terms and conditions for administration and implementation of Program, On File with the Legislative Services Division. The term of the Contract commences upon execution by the City and expires on June 30, 2023, unless sooner terminated in accordance with the terms of the Contract. The Contract may include such additions, deletions and changes as may be reasonable, necessary and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor, or his designee, with such inclusion and acceptance being evidenced by execution of the Contract by the Mayor or his designee; provided however, no modifications to the Contract may increase the financial obligations or the liability of the City or decrease the duties and obligations of the Contractor and any such modification shall be technical only and shall be subject to appropriate legal review and approval by the Office of General Counsel and the Risk Management Division for appropriate insurance and indemnification terms. the purposes of this Ordinance, the term "technical changes" is defined as those changes having no financial impact to the City and any other non-substantive changes that do not substantively increase

1	the duties and responsibilities of the City under the provisions of
2	the Contract.
3	Section 5. Oversight. The Solid Waste Division of the
4	Public Works Department shall be responsible for oversight of the
5	Pilot Program and administration of the Contract described herein on
6	behalf of the City.
7	Section 6. Effective Date. This Ordinance shall become
8	effective upon signature by the Mayor or upon becoming effective
9	without the Mayor's signature.
