AN ORDINANCE AMENDING THE JEA FISCAL YEAR 2021-2022 BUDGET; AMENDING ORDINANCE 2021-504-E (THE CITY OF JACKSONVILLE BUDGET ORDINANCE) BY AMENDING SCHEDULE C (JEA CONSOLIDATED OPERATING BUDGET) AND SCHEDULE D (JEA CONSOLIDATED CAPITAL BUDGET) TO REFLECT REVENUES EXCEEDING THE APPROVED JEA BUDGET FOR FISCAL YEAR 2021-2022; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance 2021-504-E, which included the 2021-2022 Fiscal Year Operating and Capital budgets for JEA, was enacted by Council on September 28, 2021; and

WHEREAS, a copy of Schedule C (JEA Consolidated Operating Budget) and Schedule D (JEA Consolidated Capital Budget) approved by Ordinance 2021-504-E is attached hereto as Exhibit 1; and

WHEREAS, after a review of revenues received through various systems and programs in fiscal year 2021-2022, JEA determined that revenues exceeded the approved budget for the Electric System, Water System, and District Energy System as more particularly described in the Inter-Office Memorandum dated October 25, 2022, attached hereto as Exhibit 2; and

WHEREAS, increased revenues were realized due to a variety of factors including increases in fuel and purchased power expenses, higher than budgeted sales in the Water System, increases to capacity fees for the Water System, and increased consumption revenue in the District Energy System; and

WHEREAS, on October 25, 2022, JEA approved Board Resolution

Section 1. Amendment of Ordinance 2021-504-E to Revise Schedules C and D for the Fiscal Year 2021-2022 JEA Operating and Capital Budgets. Sections 2.1 and 2.2 of Ordinance 2021-504-E are hereby amended, in part, to revise Schedule C and Schedule D to the JEA budget. Revised Schedules C and D, collectively attached hereto as Exhibit 4, are by this reference made a part of Ordinance 2021-504-E.

Section 2. Effective Date. This Ordinance shall become effective upon signature by the Mayor, or upon becoming effective without the Mayor's signature.
