AN ORDINANCE AUTHORIZING THE MAYOR TO APPLY TO THE FLORIDA INLAND NAVIGATION DISTRICT (FIND) FOR 2023 GRANTS TOUNDERTAKE SPECIFIED WATERWAYS-RELATED PROJECTS; AUTHORIZING MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ALL GRANT AGREEMENTS BETWEEN THE CITY AND FIND, AS WELL AS TO ALL DOCUMENTS RELATED SUCH GRANTS; ACKNOWLEDGING WILLINGNESS TO MEET REQUIREMENTS; PROVIDING FOR CITY OVERSIGHT BY THEDEPARTMENT OF PARKS, RECREATION COMMUNITY SERVICES; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Florida Inland Navigation District (FIND) solicits grant applications from counties within its jurisdiction to undertake waterways-related projects; and

grant applications must be accompanied by WHEREAS, FIND legislation acknowledging a county's willingness to meet the matching funding requirements; and

WHEREAS, the Department of Parks, Recreation and Community Services has compiled and recommends several grant projects for submission to FIND; and

WHEREAS, the Jacksonville Waterways Commission approved the recommended projects at its meeting on January 11, 2023; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Recitals. The recitals above are true correct and incorporated herein by reference.

Section 2. Approved Projects. The 2023 FIND grant projects recommended by the Department of Parks, Recreation and Community Services listed on Exhibit 1, attached hereto and incorporated herein by this reference (the "Projects"), are approved for submission to the Florida Inland Navigation District for purposes of receiving such The Projects are: Oak Harbor Boat Ramp Bulkhead -Construction (Council District 13); St. Johns Marina Boardwalk -Construction (Council District 5); Sisters Creek Dock Extension & Bathhouse - Design (Council District 2); and Downtown Dredging -Design (Council Districts 5 and 7), as more particularly described in **Exhibit 2**, attached hereto and incorporated herein by this reference. The four grant applications total \$4,400,000. A total of \$2,000,000 is reimbursable from FIND and the City's match totals \$2,400,000, inclusive of internal engineering fees. A list of alternative projects is also included on **Exhibit 1**. These alternatives would serve as replacement recommendations should any of the four Projects be removed from the list.

Section 3. Authorization. The Mayor, for and on behalf of the City, is hereby authorized to apply for the Florida Inland Navigation District grants for funding of the Projects.

Section 4. Execution authorized. The Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City, all grant agreements, including any grant agreement extensions, for the Projects between the City and FIND, as well as any and all documents related to such grants.

Section 5. Acknowledging Willingness to Match Funding. The City of Jacksonville is willing to meet FIND's matching funding requirements as they relate to the Projects described in Exhibit 1. Copies of FIND's Attachment E-7 (Resolution for Assistance 2023 under

1 the Florida Inland Navigation District Waterways Assistance Program) 2 for each of the Projects are attached hereto as **Exhibit 3** and 3 incorporated herein by this reference. Section 6.
