4 **ORDINANCE 2023-51**

5 AN ORDINANCE APPROPRIATING GRANT FUNDS IN THE
6 AMOUNT OF \$90,000.00 FROM THE NATIONAL HIGHWAY
7 TRAFFIC SAFETY ADMINISTRATION, THROUGH THE
8 FLORIDA DEPARTMENT OF TRANSPORTATION, TO
9 ESTABLISH THE JACKSONVILLE SHERIFF'S OFFICE
10 SPEEDING AND AGGRESSIVE DRIVING PROJECT, AS
11 INITIATED BY B.T. 23-036; PROVIDING FOR
12 OVERSIGHT BY THE JACKSONVILLE SHERIFF'S OFFICE,
13 PATROL SUPPORT DIVISION; PROVIDING AN EFFECTIVE
14 DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2022-2023 fiscal year,
18 within the City's budget, there are hereby appropriated the indicated
19 sum(s) from the account(s) listed in subsection (a) to the account(s)
20 listed in subsection (b):

27 (c) Explanation of Appropriation:

28 The funding above represents an appropriation of grant
29 funds from the National Highway Traffic Safety
30 Administration ("NHTSA"), through the State of Florida
31 Department of Transportation ("FDOT"), to establish the

1 Jacksonville Sheriff's Office Speeding and Aggressive
2 Driving Project. The grant period commenced on July 1,
3 2022 and continues through September 30, 2023. No local
4 match is required.

5 **Section 2. Purpose.** The purpose of the appropriation in
6 Section 1 is to utilize grant funding from NHTSA, made available
7 through FDOT as a Highway Traffic Safety Program subgrant, to
8 establish the Jacksonville Sheriff's Office Speeding and Aggressive
9 Driving Project (the "Project"). The purpose of the Project is to
10 reduce the incidence of serious injuries and fatalities occurring in
11 Duval County caused by speeding and aggressive driving and to improve
12 the City of Jacksonville's statistical ranking measured under the
13 Florida Strategic Highway Safety Plan. Funds will be used for a
14 variety of Project expenses including overtime salaries and benefits
15 for law enforcement officers, and to procure radar and laser
16 equipment. A copy of the Subgrant for Highway Traffic Safety Funds,
17 outlining the terms and conditions relative to the grant and use of
18 the grant funds, has been placed **On File** with the Legislative Services
19 Division.

20 **Section 3. Oversight and Reporting.** The Jacksonville
21 Sheriff's Office, Patrol Support Division, shall oversee
22 administration of the grant and Project described herein.

23 **Section 4. Effective Date.** This Ordinance shall become
24 effective upon signature by the Mayor or upon becoming effective
25 without the Mayor's signature.
