RESOLUTION 2023-77

RESOLUTION MAKING CERTAIN FINDINGS AND APPROPRIATING \$500,000 FROM THE NORTHWEST OED FUND - TRANSFER FROM FUND BALANCE FOR THE PURPOSE OF PROVIDING A \$500,000 LARGE SCALE ECONOMIC DEVELOPMENT FUND (LSEDF) GRANT TO KAPPA ALPHA PSI JACKSONVILLE FOUNDATION, INCORPORATED ("COMPANY"), AS INITIATED BY B.T. 23-038, IN CONNECTION WITH THE INFRASTRUCTURE COSTS AND BUILDING IMPROVEMENTS TO BE MADE BY THE COMPANY AT THE PROJECT PARCEL ("PROJECT"); PURPOSE OF APPROPRIATION; APPROVING AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE CITY OF JACKSONVILLE ("CITY"), THE ECONOMIC DEVELOPMENT AGREEMENT BETWEEN COMPANY AND THE CITY; AUTHORIZING A LARGE SCALE ECONOMIC DEVELOPMENT FUND (LSEDF) GRANT TO THE COMPANY IN AMOUNT OF \$500,000; DESIGNATION THE AUTHORIZED OFFICIAL AND CONTRACT MONITOR; AUTHORIZING APPROVAL OF TECHNICAL AMENDMENTS BY THE EXECUTIVE DIRECTOR OF THE OFFICE OF ECONOMIC DEVELOPMENT ("OED"); PROVIDING FOR CITY OF JACKSONVILLE OVERSIGHT BY THE OED; PROVIDING A DEADLINE FOR THE COMPANY TO EXECUTE THE AGREEMENT; AFFIRMING THE PROJECT'S COMPLIANCE WITH THE NWJEDF GUIDELINES APPROVED AND ADOPTED BY ORDINANCE 2016-779-E, AS AMENDED; WAIVER OF

 THAT PORTION OF THE PUBLIC INVESTMENT POLICY ADOPTED BY ORDINANCE 2022-372-E, AS AMENDED, TO AUTHORIZE A LARGE SCALE ECONOMIC DEVELOPMENT FUND GRANT, WHICH REQUIRES A MINIMUM OF 50 NEW JOBS; REQUESTING TWO READING PASSAGE PURSUANT TO COUNCIL RULE 3.305; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Kappa Alpha Psi Jacksonville Foundation, Incorporated (the "Company") is proposing to establish a community enrichment center and state-of-the-art healthcare facility to serve the Northwest Jacksonville community and make certain infrastructure and building improvements including demolition, site improvements, building construction, utility installation, and other improvements necessary to support the facility located at 3717 Moncrief Road, Jacksonville, Florida ("Project Parcel"), all as further described in the Project Summary attached hereto as Exhibit 1; and

WHEREAS, the Project Parcel is located in a Level 1 Economically Distressed Area in Northwest Jacksonville and is in Health Zone 1;

WHEREAS, for the reasons more fully described in the Project Summary attached hereto as Exhibit 1, the payment of the Large Scale Economic Development Fund (LSEDF) Grant in such amount serves a paramount public purpose; and

WHEREAS, the City's Office of Economic Development ("OED") has reviewed the application submitted by the Company for community development, and, together with representatives of the City, negotiated the Economic Development Agreement and, based upon the contents of the Economic Development Agreement, has determined the Economic Development and the uses contemplated therein to be in the public interest, and has determined that the public actions and financial assistance contemplated in the Economic Development Agreement take into account and give consideration to the long-term

public interests and public interest benefits to be achieved by the City; and

WHEREAS, the Company has requested the City to enter into the Economic Development Agreement in substantially the form placed On File with the Office of Legislative Services; now therefore,

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. Findings. It is hereby ascertained, determined, found and declared as follows:

- (a) The recitals set forth herein are true and correct.
- (b) The location of the Company's Project in northwest Jacksonville, Florida, is more particularly described in the Economic Development Agreement. The Project will promote and further the public and municipal purposes of the City.
- (c) Enhancement of the City's tax base and revenues are matters of State and City policy and State and City concern in order that the State and its counties and municipalities, including the City, shall not continue to be endangered by unemployment, underemployment, economic recession, poverty, crime and disease, and consume an excessive proportion of the State and City revenues because of the extra services required for police, fire, accident, health care, elderly care, charity care, hospitalization, public housing and housing assistance, and other forms of public protection, services and facilities.
- (d) The provision of the City's assistance as identified in the Economic Development Agreement is necessary and appropriate to make the Project feasible; and the City's assistance is reasonable and not excessive, taking into account the needs of the Company to make the Project economically and financially feasible, and the extent of the public benefits expected to be derived from the Project, and taking into account all other forms of assistance available.
 - (e) The Company is qualified to carry out and complete the

construction and equipping of the Project, in accordance with the Economic Development Agreement.

- (f) The authorizations provided by this Resolution are for public uses and purposes for which the City may use its powers as a county, municipality and as a political subdivision of the State of Florida and may expend public funds, and the necessity in the public interest for the provisions herein enacted is hereby declared as a matter of legislative determination.
- (g) This Resolution is adopted pursuant to the provisions of Chapters 163, 166 and 125, Florida Statutes, as amended, the City's Charter, and other applicable provisions of law.

Section 2. Appropriation. For the 2022-2023 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b): (B.T. 23-038, attached hereto as Exhibit 2 and incorporated herein by this reference):

(c) Explanation of Appropriation

The funding above appropriates \$500,000 from the Northwest OED Fund - Fund Balance, to provide a \$500,000 Large Scale Economic Development Fund Grant to the Company to assist with costs associated with infrastructure and building construction needed to complete the Project.

Section 3. Purpose. The purpose of the appropriation in Section 2 is to provide a \$500,000 Large Scale Economic Development Fund Grant to the Company. The Company, together with Wolfson's Children's Hospital of Jacksonville, proposes to establish a community enrichment center and state-of-the-art healthcare facility

to serve the Northwest Jacksonville community at the Project Parcel, and cause private capital investment in the estimated amount of \$8,300,000. The NWJEDF Advisory Board recommended City Council's approval of the Company's grant application at its January 19, 2023 meeting.

Section 4. Economic Development Agreement Approved. The Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City, the Economic Development Agreement substantially in the form placed On File with the Office of Legislative Services (with such "technical" changes as herein authorized), for the purpose of implementing the recommendations of the OED, as are further described in the Project Summary attached hereto as Exhibit 1.

The Economic Development Agreement may include such additions, deletions, and changes as may be reasonable, necessary, and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor or his designee, with such inclusion and acceptance being evidenced by execution of the Economic Development Agreement by the Mayor or his designee. No modification of the Economic Development Agreement may increase the financial obligations or the liability of the City and any such modification shall be technical only and shall be subject to appropriate legal review and approval of the General Counsel or his or her designee and all other appropriate action required by law. "Technical" is herein defined as including, but not limited to, changes in legal descriptions and surveys, descriptions of infrastructure improvements and/or any road project, ingress and egress, easements and rights of way, performance schedules (provided that no performance schedule may be extended for more than one year without City Council approval), design standards, access and site plans which have no financial impact.

Section 5. Payment of Large Scale Economic Development Fund

(LSEDF) Grant. The Mayor, or his designee, is hereby authorized to and shall disburse the LSEDF Grant in accordance with this Resolution and the Agreement.

Designation of Authorized Official/OED Contract Section 6. Monitor. The Mayor is designated as the authorized official of the City for the purpose of executing and delivering any contracts and documents and furnishing such information, data and documents for the Agreement and related documents as may be required and otherwise to act as the authorized official of the City in connection with the Agreement, and is further authorized to designate one or more other officials of the City to exercise any of the foregoing authorizations and to furnish or cause to be furnished such information and take or cause to be taken such action as may be necessary to enable the City to implement the Agreement according to its terms. The OED is hereby required to administer and monitor the Agreement and to handle the thereunder, City's responsibilities including responsibilities under such Agreement working with and supported by all relevant City departments.

Section 7. Further Authorizations. The Mayor, or his designee, and the Corporation Secretary, are hereby authorized to execute the Economic Development Agreement and all other contracts and documents and otherwise take all necessary action in connection therewith and herewith. The Executive Director of the OED, as contract administrator, is authorized to negotiate and execute all necessary changes and amendments to the Economic Development Agreement and other contracts and documents, to effectuate the purposes of this Resolution, without further Council action, provided such changes and amendments are limited to amendments that are technical in nature (as described in Section 4 hereof), and further provided that all such amendments shall be subject to appropriate legal review and approval by the General Counsel, or his or her designee, and all other

appropriate official action required by law.

Section 8. Oversight Department. The Office of Economic Development shall oversee the Project described herein.

Section 9. Execution of the Economic Development Agreement.

If the Economic Development Agreement approved by this Resolution has not been signed by the Company within ninety (90) days after the OED delivers or mails the unexecuted Economic Development Agreement to the Company for execution, then the City Council approvals in this Resolution and authorization for the Mayor to execute the Agreement are automatically revoked; provided, however, that the Executive Director of the OED shall have the authority to extend such ninety (90) day period in writing at his discretion for up to an additional ninety (90) days.

NWJEDF Guidelines. Section 10. This Resolution conforms to the NWJEDF Guidelines adopted by City Council Ordinance 2016-779-E, as amended.

Public Section 11. Waiver of Investment Policy. The requirements of the Public Investment Policy adopted by City Council Ordinance 2022-372-E, as amended, are waived to authorize an LSEDF Grant that requires a minimum of 50 new jobs. The waiver is justified due to the fact that the Company will cause significant private capital investment of approximately \$8,300,000 in Jacksonville, and the Company will further the Mayor's stated priorities of health, wellness and youth development by establishing a community enrichment center and state-of-the-art healthcare facility to serve the Northwest Jacksonville community in a Health Zone 1 area, which is deemed to have the highest level of health disparities in Duval County, Florida.

Section 12. Requesting two reading passage pursuant Council Rule 3.305. Two reading passage of this legislation is requested pursuant to Council Rule 3.305.
