5 AN ORDINANCE REZONING APPROXIMATELY 3.92± ACRES 6 LOCATED IN COUNCIL DISTRICT 9 AT 0 KOHN STREET 7 AND 0 118TH STREET, BETWEEN BLANDING BOULEVARD JAMMES ROAD (R.E. NOS. 097894-0000 AND 8 AND 9 097898-0000), OWNED BY HOOSE A, LLC, AS DESCRIBED HEREIN, FROM RESIDENTIAL LOW DENSITY-60 (RLD-60) 10 DISTRICT TO COMMERCIAL, RESIDENTIAL AND OFFICE 11 12 (CRO) DISTRICT, AS DEFINED AND CLASSIFIED UNDER 13 THE ZONING CODE, PURSUANT TO FUTURE LAND USE MAP 14 SERIES SMALL-SCALE AMENDMENT APPLICATION NUMBER 15 L-5789-22C; PROVIDING A DISCLAIMER THAT THE REZONING GRANTED HEREIN SHALL NOT BE CONSTRUED 16 AS AN EXEMPTION FROM ANY OTHER APPLICABLE LAWS; 17 18 PROVIDING AN EFFECTIVE DATE.

20 WHEREAS, the City of Jacksonville adopted a Small-Scale 21 Amendment to the 2030 Comprehensive Plan for the purpose of revising 22 portions of the Future Land Use Map series (FLUMs) in order to ensure 23 the accuracy and internal consistency of the plan, pursuant to 24 companion application L-5789-22C; and

WHEREAS, in order to ensure consistency of zoning district with the 2030 Comprehensive Plan and the adopted companion Small-Scale Amendment L-5789-22C, an application to rezone and reclassify from Residential Low Density-60 (RLD-60) District to Commercial, Residential and Office (CRO) District was filed by Zach Miller, Esq., on behalf of the owner of approximately 3.92± acres of certain real property in Council District 9, as more particularly described in Section 1; and

2 WHEREAS, the Planning and Development Department, in order to 3 ensure consistency of this zoning district with the 2030 Comprehensive 4 Plan, has considered the rezoning and has rendered an advisory 5 opinion; and

6 WHEREAS, the Planning Commission has considered the application
7 and has rendered an advisory opinion; and

8 WHEREAS, the Land Use and Zoning (LUZ) Committee, after due 9 notice, held a public hearing and made its recommendation to the 10 Council; and

11 WHEREAS, the City Council, after due notice, held a public 12 hearing, and taking into consideration the above recommendations as 13 well as all oral and written comments received during the public 14 hearings, the Council finds that such rezoning is consistent with the 15 *2030 Comprehensive Plan* adopted under the comprehensive planning 16 ordinance for future development of the City of Jacksonville; now, 17 therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

19 Section 1. Subject Property Location and Description. The 20 approximately 3.92± acres are located in Council District 9 at 0 Kohn 21 Street and 0 118th Street, between Blanding Boulevard and Jammes Road (R.E. Nos. 097894-0000 and 097898-0000), as more particularly 22 23 described in Exhibit 1, dated December 13, 2022, and graphically 24 depicted in Exhibit 2, both of which are attached hereto and 25 incorporated herein by this reference (the "Subject Property").

Section 2. Owner and Applicant Description. The Subject Property is owned by Hoose A, LLC. The applicant is Zach Miller, Esq., 3203 Old Barn Court, Ponte Vedra Beach, Florida 32082; (904) 651-8958.

30 Section 3. Property Rezoned. The Subject Property,
31 pursuant to adopted companion Small-Scale Amendment Application L-

1 5789-22C, is hereby rezoned and reclassified from Residential Low 2 Density-60 (RLD-60) District to Commercial, Residential and Office 3 (CRO) District.

4 Section 4. Contingency. This rezoning shall not become 5 effective until thirty-one (31) days after adoption of the companion 6 Small-Scale Amendment; and further provided that if the companion 7 Small-Scale Amendment is challenged by the state land planning agency, 8 this rezoning shall not become effective until the state land planning 9 agency or the Administration Commission issues a final order 10 determining the companion Small-Scale Amendment is in compliance with 11 Chapter 163, Florida Statutes.

12 Section 5. Disclaimer. The rezoning granted herein 13 shall **<u>not</u>** be construed as an exemption from any other applicable 14 local, state, or federal laws, regulations, requirements, permits or 15 approvals. All other applicable local, state or federal permits or 16 approvals shall be obtained before commencement of the development 17 or use and issuance of this rezoning is based upon acknowledgement, 18 representation and confirmation made by the applicant(s), owner(s), 19 developer(s) and/or any authorized agent(s) or designee(s) that the 20 subject business, development and/or use will be operated in strict 21 compliance with all laws. Issuance of this rezoning does **not** approve, 22 promote or condone any practice or act that is prohibited or 23 restricted by any federal, state or local laws.

Section 6. Effective Date. The enactment of this Ordinance shall be deemed to constitute a quasi-judicial action of the City Council and shall become effective upon signature by the Council President and the Council Secretary.
