AN ORDINANCE APPROPRIATING \$300,000 IN GRANT FUNDING FROM THE U.S. DEPARTMENT OF JUSTICE, OFFICE OF JUSTICE PROGRAMS, TO KIDS ALLIANCE ("KHA") FOR IMPLEMENTATION OF PROJECT (RESPONDING AND INTERVENING STRENGTH AND EMPOWERMENT), A PROGRAM AIMED AT INCREASING THE RESILIENCY OF CHILDREN AND YOUTH EXPOSED TO VIOLENCE, FOR THE FIRST YEAR OF A THREE YEAR GRANT TERM BEGINNING OCTOBER 1, 2022 THROUGH SEPTEMBER 30, 2025, AS INITIATED BY B.T. 23-041; AMENDING THE SECOND REVISED SCHEDULE M TO ORDINANCE 2022-511-E; INVOKING THE EXEMPTION IN SECTION 126.107(G), ORDINANCE CODE, WITH RESPECT TO SERVICES TO BE PROVIDED BY MANAGED ACCESS TO CHILD HEALTH, INC.; APPROVING, AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE SECRETARY, CORPORATION AND/OR THECHIEF EXECUTIVE OFFICER OF KIDS HOPE ALLIANCE, EXECUTE AND DELIVER A CONTRACT WITH MANAGED ACCESS TO CHILD HEALTH, INC. (c) Explanation of Appropriation:

The funding above represents an appropriation of grant funds in the amount of \$300,000 from the U.S. Department of Justice, Office of Justice Programs (under the funding opportunity entitled "2022 OJJDP FY 2022 Strategies to Support Children Exposed to Violence"), to Kids Hope Alliance ("KHA") for implementation of Project RISE (Responding and Intervening through Strength Empowerment). The overall grant term is three years beginning October 1, 2022 and ending September 30, 2025 with the opportunity for a no cost extension for up to one additional year. No local match is required.

Purpose. The purpose of the appropriation in Section 2. Section 1 is to fund the first year of Project RISE for the period beginning October 1, 2022 through September 30, 2023 and to procure the professional services of Managed Access to Child Health, Inc.

("MATCH") to implement and administer Project RISE. The purpose of Project RISE is to develop and implement prevention strategies at an individual and community level to increase resiliency of children and youth exposed to violence. This will be accomplished through application of strategies that address the following objectives: (1) improving family and community responses to children exposed to violence; (2) increasing protective factors to prevent juvenile violence, delinquency, and victimization and reducing the impact of exposure to violence on children; and (3) helping communities to develop, design, and implement prevention and early intervention strategies to support children exposed to violence. Copies of the Office of Justice Programs Award Letter and Award Conditions have been placed **On File** with the Office of Legislative Services.

Section 3. Amending the Second Revised Schedule M to Ordinance 2022-511-E. There is hereby amended for the fiscal year 2022-2023 budget for Kids Hope Alliance by substituting in the place of Second Revised Schedule M, approved by Ordinance 2022-886-E, the Third Revised Schedule M, attached hereto as Revised Exhibit 2, labeled as "Revised Exhibit 2, 3rd Rev Schedule M, March 6, 2023 - NCSPHS" and incorporated herein by this reference. The Third Revised Schedule M will reflect the additional transfers and funds appropriated herein.

Section 4. Invoking the Exemption in Section 126.107(g), Ordinance Code. KHA is hereby authorized to procure professional services from Managed Access to Child Health, Inc. ("MATCH") for implementation and administration of Project RISE in compliance with the grant described herein. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such services are exempted from competitive solicitation because the services are to be provided by those specifically prescribed within authorizing legislation that

appropriates the same.

Mayor, or his designee, and the Corporation Secretary, and/or the Chief Executive Officer of KHA, are hereby authorized to execute and deliver a contract between KHA and Managed Access to Child Health, Inc., including any amendments thereto as necessary to comply with the terms and conditions of the grant or to extend the contract term in conjunction with any extension to the grant term, pursuant to which MATCH will provide professional services necessary for implementation and administration of Project RISE in compliance with the terms of the grant and in accordance with the goals, objectives and timeline outlined in **Exhibit 3** attached hereto and incorporated herein by this reference.

(Provider Contracts), Chapter 77 (Kids Hope Alliance), Ordinance Code. The City hereby waives the requirements of Section 77.111(a) (Provider Contracts), Chapter 77 (Kids Hope Alliance), Ordinance Code, with respect to the contract with Managed Access to Child Health, Inc. approved and authorized in Section 5 of this Ordinance. Section 77.111(a), Ordinance Code, requires contracts for children's services provided by third parties to be competitively procured by KHA via an evaluated bid process. This waiver is needed in order to allow KHA to directly contract with MATCH to provide the Project RISE services described in the approved grant application.

Section 7. Oversight and Reporting. The Kids Hope Alliance shall oversee administration of the grant and Project RISE.

Section 8. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
