LOCATED IN THE NORTHWESTERLY CORNER OF LOT 35 BLOCK 1 OF THE DUVAL CITY ADDITION AND FARMS PLAT, AS RECORDED IN PLAT BOOK 6, PAGE(S) 57 OF THE CURRENT PUBLIC RECORDS OF DUVAL COUNTY, FLORIDA; THENCE N 89*34'50" E 211.60 FEET; THENCE S 00*24'29" E 89.55 FEET; THENCE N 89*35'29" E 49.89 FEET; THENCE S 00*24'31" E 50.41 FEET; THENCE S 89*35'31" W 266.16 FEET; THENCE N 01*26'46" E 140.01 FEET TO THE POINT OF THE BEGINNING.
