6 AN ORDINANCE APPROPRIATING A \$7,000.00 GRANT
7 FROM THE COMMUNITY FOUNDATION FOR NORTHEAST
8 FLORIDA, INC. TO FUND ONLINE CLASSES FOR YOUTH
9 IN TEEN COURT DIVERSION PROGRAMS, AS INITIATED
10 BY B.T. 23-045; PROVIDING FOR OVERSIGHT BY THE
11 COURT ADMINISTRATION, DIRECTOR OF TEEN COURTS;
12 PROVIDING AN EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Appropriation.** For the 2022-2023 fiscal year,
16 within the City's budget, there is hereby appropriated the indicated
17 sum(s) from the account(s) listed in subsection (a) to the account(s)
18 listed in subsection (b):

25 (c) Explanation of Appropriation:

26 The funding above represents an appropriation of grant
27 funds received from The Community Foundation for Northeast
28 Florida, Inc. ("Community Foundation"), to offset certain
29 costs for the Duval County Teen Court program. The grant
30 period commenced on February 1, 2023 and terminates on
31 September 30, 2023. No City match is required.

1 **Section 2. Purpose.** The purpose of the appropriation in
2 Section 1 is to provide funding for the Duval County Teen Court
3 program to offset costs associated with online classes provided to
4 youth in the Teen Court diversion programs. This is a one-time grant
5 from Community Foundation's discretionary funds. A copy of the Grant
6 Award Letter providing the terms and conditions for the grant is
7 attached hereto as **Exhibit 2.**

8 **Section 3. Oversight.** The Court Administration, Director
9 of Teen Courts, shall oversee administration of the grant described
10 herein.

11 **Section 4. Effective Date.** This Ordinance shall become
12 effective upon signature by the Mayor or upon becoming effective
13 without the Mayor's signature.
