13 **WHEREAS**, pursuant to Section 50.0311 (Publication of
14 advertisements and public notices on a publicly accessible website
15 and governmental access channels), Chapter 50 (Legal and Official
16 Advertisements), *Florida Statutes*, counties and municipalities are
17 permitted to use a publicly accessible website, as defined in Section
18 50.0311(2), *Florida Statutes*, to publish legally required
19 advertisements and public notices; and

20 **WHEREAS**, pursuant to Section 50.0311, *Florida Statutes*, the City
21 has determined that the cost of publishing advertisements and public
22 notices on a publicly accessible website are less than the costs of
23 publishing such advertisements and notices in a newspaper; and

24 **WHEREAS**, the City believes that publishing certain
25 advertisements and public notices via a publicly accessible website
26 will be more economical and beneficial to the citizens of Jacksonville
27 in various ways; now therefore

28 **BE IT ORDAINED** by the Council of the City of Jacksonville:

29 **Section 1. Recitals.** The recitals above are incorporated
30 herein by this reference.

31 **Section 2. Findings.** It is hereby ascertained, determined,

1 found, and declared as follows:

2 (a) The recitals set forth herein are true and correct.

3 (b) The City through its Information Technology Division has
4 established a publicly accessible website in compliance with Section
5 50.0311, *Florida Statutes*.

6 (c) The City's costs to maintain a publicly accessible website
7 in compliance with Section 50.0311, *Florida Statutes*, for City
8 agencies are less than the City's costs to publish legally required
9 advertisements and public notices in local newspapers.

10 (d) This ordinance is adopted pursuant to the provisions of
11 Chapters 50, 166 and 125, *Florida Statutes*, as amended, the City's
12 Charter, and other applicable provisions of law.

13 **Section 3. Amending Section 3.107 (Reserved), Chapter 3**
14 **(Legislation; Legislative Records), Ordinance Code.** Section 3.107
15 (Reserved), Chapter 3 (Legislation; Legislative Records), *Ordinance*

20 For purposes of any legal notices or advertisements required under
21 Section 50.011, *Florida Statutes*, this Code, or for the City Council
22 to enact ordinances or resolutions, such legal notices or
23 advertisements may be published in accordance with Section 50.011,
24 *Florida Statutes*, the applicable Code chapter requirements, or such
25 other advertisement or notice method as permitted by law (e.g.,
26 publicly accessible website).

29 **Districts), Ordinance Code.** A new Section 92.23 (Public notice and

3 **Sec. 92.23. - Public notice and advertisement methods.** Any public
4 notice or advertisement required in this Chapter to be published in
5 a newspaper of general circulation is also permitted to be published
6 via such other advertisement or notice method as permitted by law
7 (e.g., publicly accessible website).

23 (a) Public auction. If the Chief of the Real Estate Division
24 determines that a property may be more advantageously
25 disposed of by public auction, the Chief may sell the property
26 at public auction to the highest and best bidder for cash,
27 after publication of a notice of the auction in a newspaper
28 of general circulation in the City, or via such other
29 advertisement or notice method as permitted by law (e.g., a
30 publicly accessible website), published at least ten days
31 before the date of the auction, setting forth the date, time

1 and place of the auction and a legal description and street
2 address (if available) of the surplus real property. Persons
3 who have requested notice from the Real Estate Division of
4 auctions of City-owned property shall be notified of the date
5 and time and place of property auctions.

6 (b) *Sealed bid.* The Real Estate Division may choose to submit any
7 City-owned surplus property to the Procurement Division for
8 sale through a sealed bid process. The Real Estate Division
9 may request the Procurement Division to advertise the
10 property for sale in a local newspaper of general circulation,
11 or via such other advertisement or notice method as permitted
12 by law (e.g., a publicly accessible website), for a minimum
13 bid equal to the appraised value, if an appraisal was
14 obtained, but no less than 25% of the assessed value. The
15 bidding period shall remain open for ten days after
16 publication of the notice. The property shall be sold to the
17 highest bidder for cash whose bid meets or exceeds the minimum
18 bid.

20 **Sec. 122.430.3. - Exchanges.**

21 (a) *Notice.* Before any exchange of property occurs, a notice
22 setting forth the terms and conditions of the exchange of
23 property shall be published once a week for at least two weeks
24 in a newspaper of general circulation published in the City,
25 or via such other advertisement or notice method as permitted
26 by law (e.g., a publicly accessible website), before the
27 exchange of properties.

10 **Sec. 122.811. - Sales of tangible personal property; prohibition of**
11 **sales to certain persons.**

12 (a) The procedures in Section 126.202 may be used with respect to
13 sales of tangible personal property where the estimated sales
14 price exceeds \$1,000, except that awards shall be made to the
15 highest, rather than the lowest, responsible bidder meeting
16 or exceeding published specifications. In the alternative,
17 the Chief of Procurement may sell the property at a public
18 auction, be it in-person or online, to the highest responsible
19 bidder, payable by a method accepted by the applicable
20 auctioneer. Notice of the date, time and place of an in-
21 person auction, as well as a general description of the items
22 to be offered for sale, shall be published in a newspaper of
23 general circulation in the City, or via such other
24 advertisement or notice method as permitted by law (e.g., a
25 publicly accessible website), and on the Procurement
26 Division's public website, at least ten days prior to the in-
27 person auction date. Online auctions shall take place at a
28 time and duration as determined by the Chief of Procurement
29 without such notification requirement, provided that a
30 description of the online auction process and a link to the

1 online auctioneer's website is published on the Procurement
2 Division's public website.

3 * * *

4 **Sec. 122.814. - Disposal of surplus timber.**

5 The disposal of cut or uncut timber, after being declared surplus
6 by the using agency and the permit required by chapter 304 having
7 been obtained, may be made by the Chief of Procurement according to
8 the following:

9 (a) If the estimated value is \$1,000 or more, to the highest
10 bidder meeting or exceeding specifications after publication in a
11 local newspaper of general circulation or via such other advertisement
12 or notice method as permitted by law (e.g., a publicly accessible
13 website).

9 immediately published once in at least one newspaper of general
10 circulation in the City, or via such other advertisement or notice
11 method as permitted by law (e.g., a publicly accessible website), and
12 shall be publicized by all available media of communication to the
13 general public. Upon the signing of the water pollution emergency
14 declaration by the Mayor, the special powers herein granted shall
15 become available to the Mayor and he shall have plenary authority to
16 execute these powers. The Mayor may delegate the daily execution of
17 these powers to an executive officer, but he:

- 18 (a) Shall be immediately responsible for the proper
19 exercise of this delegated authority.
- 20 (b) May withdraw this delegation of authority and
21 redelegate it to another executive officer, as often
22 as he thinks proper.
- 23 (c) May delegate execution of these powers to more than
24 one executive officer at a time, jointly or severally,
25 consecutively or successively.

27 **Sec. 362.209. - Modification, extension and cancellation of**
28 **declaration.**

29 The Mayor may, at any time during a water pollution emergency
30 modify his declaration to exclude any area of the City previously
31 covered by the declaration but as to which a water pollution emergency

1 no longer exists; or extend his declaration to cover and include any
2 area of the City not previously covered by the declaration but as to
3 which area a water pollution emergency presently exists. The Mayor
4 may cancel his declaration that a water pollution emergency exists
5 within the City, or such part hereof as may then be covered by the
6 declaration; in such event, the cancellation shall be published once
7 in a newspaper of general circulation in the City, or via such other
8 advertisement or notice method as permitted by law (e.g., a publicly
9 accessible website), and publicized by all available media of
10 communication to the general public.

10 **Chapter 656 (Zoning Code), Ordinance Code.** Section 656.1015 (Public
11 Awareness), Subpart B (Requirements for Both Civilian and Military
12 Airports), Part 10 (Regulations Related to Airports and Lands Adjacent
13 Thereto), Chapter 656 (Zoning Code), *Ordinance Code*, is hereby amended
14 as follows:

22 **Sec. 656.1015. - Public Awareness.**

23 Citizens and property owners located within the Airport Noise
24 and Airport Notice Zones shall be made aware of the potential for
25 objectionable noise impacts via the following methods: (a) Public
26 notice of the existence of airport Noise and Airport Notice maps
27 shall be published by the Jacksonville Planning and Development
28 Department at least three times a year in a newspaper of general
29 circulation as provided in the Laws of Florida, Ch. 96-193, or via
30 such other advertisement or notice method as permitted by law (e.g.,
31 a publicly accessible website); and (b) Airport Environ, Airport

1 Noise and Airport Notice maps shall be made available for inspection
2 on the City's Website.

3 * * *

4 **Section 16. Publicly Accessible Website Directive.** The
5 Information Technology Division shall be responsible for maintaining
6 the City's publicly accessible website in accordance with Section
7 50.0311, *Florida Statutes*. The Mayor, or his designee, shall ensure
8 that the requirements regarding (i) providing annual notice; and (i)
9 maintaining a registry of names, addresses, and email addresses of
10 property owners and residents who have requested in writing to receive
11 legally required advertisements and public notices from the City by
12 first-class mail or email, are met in accordance with Section 50.0311,
13 *Florida Statutes*.

14 **Section 17. Oversight.** The Information Technology Division
15 shall have oversight as provided in Section 16 of this ordinance as
16 it pertains to maintaining the City's publicly accessible website.

17 **Section 18. Reporting.** When a City department intends to
18 transition from publication of notices by newspaper to electronic
19 advertising or vice versa, notification of that intent and a copy of
20 the cost comparison required pursuant to Section 50.0311(3), *Florida*
21 *Statutes*, shall be filed with the City Council no less than 30 days
22 prior to the intended transition date.

23 **Section 19. Codification Instructions.** The Codifier and the
24 Office of General Counsel are authorized to make all chapter and
25 division "tables of contents" consistent with the changes set forth
26 herein. Such editorial changes and any others necessary to make the
27 *Ordinance Code* consistent with the intent of this legislation are
28 approved and directed herein, and changes to the *Ordinance Code* shall
29 be made forthwith and when inconsistencies are discovered.

30 **Section 20. Effective Date.** This Ordinance shall become
31 effective upon signature by the Mayor or upon becoming effective

1 without the Mayor's signature.
