23 WHEREAS, pursuant to the provisions of Section 650.402(b), 24 Ordinance Code, and Section 163.3187(1), Florida Statutes, an 25 application for a proposed Small-Scale Amendment to the Future Land 26 Use Map series (FLUMs) of the 2045 Comprehensive Plan to change the 27 Future Land Use designation from Community/General Commercial (CGC) to Light Industrial (LI) on 10.96± acres of certain real property in 28 29 Council District 12 was filed by Steve Diebenow, Esq., on behalf of 30 the owner, Carlybird Properties, LLC; and

WHEREAS, the Planning and Development Department reviewed the

proposed revision and application and has prepared a written report and rendered an advisory recommendation to the City Council with respect to the proposed amendment; and

WHEREAS, the Planning Commission, acting as the Local Planning Agency (LPA), held a public hearing on this proposed amendment, with due public notice having been provided, reviewed and considered comments received during the public hearing and made its recommendation to the City Council; and

1 to carry out the purpose and intent of, and exercise the authority 2 set out in, the Community Planning Act, Sections 163.3161 through 3 163.3248, *Florida Statutes*, and Chapter 166, *Florida Statutes*, as 4 amended.

5 Section 2. Subject Property Location and Description. The approximately 10.96± acres are located in Council District 12 at 0 6 7 Normandy Boulevard and 12223 Normandy Boulevard, between Normandy Boulevard and Cecil Commerce Center Parkway (R.E. Nos. 002168-0000, 8 002172-0000 and 002173-0000), as more particularly described in 9 Exhibit 1, dated October 5, 2022, and graphically depicted in Exhibit 10 2, both attached hereto and incorporated herein by this reference 11 12 (the "Subject Property").

Section 3. Owner and Applicant Description. The Subject
Property is owned by Carlybird Properties, LLC. The applicant is

17 Section 4. Adoption of Small-Scale Land Use Amendment. The 18 City Council hereby adopts a proposed Small-Scale revision to the 19 Future Land Use Map series of the 2045 Comprehensive Plan by changing 20 the Future Land Use Map designation of the Subject Property from 21 Community/General Commercial (CGC) to Light Industrial (LI), pursuant 22 to Application Number L-5767-22C.

Applicability, Effect and Legal Status. 23 Section 5. The applicability and effect of the 2045 Comprehensive Plan, as herein 24 25 amended, shall be as provided in the Community Planning Act, Sections 26 163.3161 through 163.3248, Florida Statutes, and this Ordinance. All 27 development undertaken by, and all actions taken in regard to development orders by governmental agencies in regard to land which 28 29 is subject to the 2045 Comprehensive Plan, as herein amended, shall be consistent therewith as of the effective date of this amendment 30 31 to the plan.

6. Effective Date of this Plan Amendment.

(a) If the amendment meets the criteria of Section 163.3187,
Florida Statutes, as amended, and is not challenged, the effective
date of this plan amendment shall be thirty-one (31) days after
adoption.

6 (b) If challenged within thirty (30) days after adoption, the 7 plan amendment shall not become effective until the state land 8 planning agency or the Administration Commission, respectively, issue 9 a final order determining the adopted Small-Scale Amendment to be in 10 compliance.

Section 7. Disclaimer. The amendment granted herein shall 11 12 not be construed as an exemption from any other applicable local, state, or federal laws, regulations, requirements, permits or 13 approvals. All other applicable local, state or federal permits or 14 15 approvals shall be obtained before commencement of the development 16 or use, and issuance of this amendment is based upon acknowledgement, representation and confirmation made by the applicant(s), owner(s), 17 developer(s) and/or any authorized agent(s) or designee(s) that the 18 subject business, development and/or use will be operated in strict 19 20 compliance with all laws. Issuance of this amendment does not approve, promote or condone any practice or act that is prohibited or 21 22 restricted by any federal, state or local laws.

23 Section 8. Effective Date. This Ordinance shall become 24 effective upon signature by the Mayor or upon becoming effective 25 without the Mayor's signature.
