The delicatessen was established in 1927 and was owned and operated by Sam's father, Boulos "Paul" Salem, from 1962 until 1975 when Sam took over the business; and

WHEREAS, for 40 years Mr. Salem operated Whiteway Deli as a neighborhood institution where regulars and newcomers alike from around the city were served good food and treated as family, and photos of hundreds of satisfied customers covered the walls as testimony to the enjoyment the restaurant provided to its patrons; and

WHEREAS, in addition to his devotion to the family business, Mr. Salem was deeply involved in community service, serving on the boards of directors of the Park and King Merchants Association, Riverside Avondale Preservation, St. Mark's Episcopal Day School, and
