4 **RESOLUTION 2023-318**

5 A RESOLUTION REAPPOINTING JILL D. HASKELL AS A  
6 MEMBER OF THE JACKSONVILLE WATERWAYS COMMISSION,  
7 AS A GENERAL PUBLIC REPRESENTATIVE, PURSUANT TO  
8 CHAPTER 95, *ORDINANCE CODE*, FOR A THIRD FULL  
9 TERM EXPIRING DECEMBER 31, 2024; PROVIDING AN  
10 EFFECTIVE DATE.

12 **WHEREAS**, Jill D. Haskell was initially appointed to the  
13 Jacksonville Waterways Commission ("JWC") pursuant to Resolution  
14 2015-134-A for a partial term ending December 31, 2015; and

15 **WHEREAS**, Ms. Haskell was subsequently reappointed to the JWC  
16 for a first full term ending December 31, 2018 pursuant to Resolution  
17 2016-816-A, and again for a second full term ending December 31, 2021  
18 pursuant to Resolution 2018-724-A; and

19 **WHEREAS**, in accordance with Section 95.103, *Ordinance Code*,  
20 Jacksonville Waterways Commission members from the general public  
21 serve for three-year staggered terms or until their successors are  
22 appointed by the City Council and may serve for up to three  
23 consecutive full terms; and

24 **WHEREAS**, while continuing to serve on the JWC for what would  
25 be considered her third term, Jill D. Haskell submitted a letter of  
26 resignation to JWC Chair Howland on February 7, 2023; and

27 **WHEREAS**, due to a change in circumstances, Ms. Haskell now  
28 wishes to resume her JWC appointment to complete the remainder of her  
29 third term, ending December 31, 2024; now therefore

30 **BE IT RESOLVED** by the Council of the City of Jacksonville:

31 **Section 1. Reappointment.** The Council hereby reappoints

1 Jill D. Haskell, a Duval County resident, to the Jacksonville  
2 Waterways Commission, as a general public representative, in  
3 accordance with Chapter 95, *Ordinance Code*, for a third full term  
4 ending December 31, 2024.

5 **Section 2. Effective Date.** This Resolution shall become  
6 effective upon signature by the Mayor or upon becoming effective  
7 without the Mayor's signature.
