Section 2. Purpose. The purpose of the appropriation in Section 1 is to transfer funds from the Neighborhoods Department Fight Blight Awareness Campaign to purchase food and beverage for certain special events and activities hosted by the Neighborhood Services Office. A majority of these events are held on an annual basis for leadership training and CPAC membership recruitment. These events include, but are not limited to, CommUniverCity, community leadership programs, and the Neighborhood Awards Program which, this year, will be combined with the 30th Anniversary celebration of CPACs.

Section 3. Amending Ordinance 2022-504-E, the Fiscal Year 2022-2023 Budget, to Amend Revised Attachment A. Ordinance 2022-504-E, adopting the 2022-2023 fiscal year budget, is hereby amended to replace the Revised Attachment A, entitled "Food and Beverage Expenditures", to authorize expenditure of these funds for the purchase of food and beverage for the purposes outlined above. The Second Revised Attachment A is attached hereto as Exhibit 2 and incorporated herein by this reference.

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
