13 FISCAL YEAR 2022-2023 BUDGET, BY AMENDING THE
14 REVISED ATTACHMENT A TO AUTHORIZE EXPENDITURE OF
15 THESE FUNDS ON FOOD AND BEVERAGE FOR SPECIAL
16 EVENTS AND ACTIVITIES; PROVIDING FOR AN
17 EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2022-2023 fiscal year,
21 within the City's budget, there is hereby appropriated the indicated
22 sum from the account(s) listed in subsection (a) to the account(s)
23 listed in subsection (b):

31 The funding above is an appropriation of \$5,500.00 from

1 the Neighborhoods Department Fight Blight Awareness
2 Campaign Advertising and Promotion Account to purchase food
3 and beverage for various special events and activities for
4 leadership training and recruitment of new Citizens
5 Planning Advisory Committee ("CPAC") members.

6 **Section 2. Purpose.** The purpose of the appropriation in
7 Section 1 is to transfer funds from the Neighborhoods Department
8 Fight Blight Awareness Campaign to purchase food and beverage for
9 certain special events and activities hosted by the Neighborhood
10 Services Office. A majority of these events are held on an annual
11 basis for leadership training and CPAC membership recruitment. These
12 events include, but are not limited to, CommUniverCity, community
13 leadership programs, and the Neighborhood Awards Program which, this
14 year, will be combined with the 30th Anniversary celebration of CPACs.

15 **Section 3. Amending Ordinance 2022-504-E, the Fiscal Year**
16 **2022-2023 Budget, to Amend Revised Attachment A.** Ordinance 2022-504-
17 E, adopting the 2022-2023 fiscal year budget, is hereby amended to
18 replace the Revised Attachment A, entitled "Food and Beverage
19 Expenditures", to authorize expenditure of these funds for the
20 purchase of food and beverage for the purposes outlined above. The
21 Second Revised Attachment A is attached hereto as **Exhibit 2** and
22 incorporated herein by this reference.

23 **Section 4. Effective Date.** This Ordinance shall become
24 effective upon signature by the Mayor or upon becoming effective
25 without the Mayor's signature.
