The City is proposing to utilize the Recapture Enhanced Value (REV) Grant program as stated in the City's Public Investment Policy (PIP). The REV Grant program requires the creation of "at least 10 full-time jobs" and a minimum of \$10 million of investment in order to be exempt those jobs from the wage requirement. The company is investing a total of \$61 million and creating 100 jobs. Based on the number of jobs and capital investment, the City is proposing a REV Grant in the amount of 50 percent of the increase in real and personal property taxes generated at the project site, for 5 years, up to a maximum of \$1.5 million.

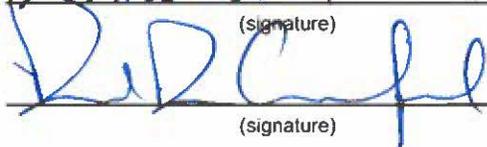
