annual grant funds from the U.S. Department of Housing and Urban Development ("HUD") for the Housing Opportunities for Persons with AIDS ("HOPWA") program. The HOPWA program is administered by the Housing and Community Development Division and was established to provide housing assistance and related supportive services to eligible low-income persons living with HIV/AIDS and their families. The HOPWA program grant funds must be expended within 36 months after HUD signs the grant agreement.

10 Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding for housing assistance and related 11 12 supportive services to eligible low-income persons living with HIV/AIDS and their families. The HOPWA program provides funding that 13 can be used for a wide range of housing, social services, program 14 planning, and development cost expenditures for eligible persons and 15 their families. Housing assistance may include the acquisition, 16 17 rehabilitation or new construction of housing units, costs for facility operations, rental assistance, and short-term payments to 18 19 prevent homelessness. In addition, an essential component to 20 providing housing assistance for this targeted, special needs 21 population is the coordination and delivery of supportive services. 22 Consequently, HOPWA funds may also be used for services that include, 23 but are not limited to, assessment and case management, substance 24 abuse treatment, mental health treatment, nutritional services, job 25 training and placement assistance, and assistance with daily living 26 activities. The Schedule of Proposed Funding detailing the proposed 27 uses of HOPWA funds is attached hereto as **Exhibit 2** and incorporated 2.8 herein by this reference.

Section 3. Authorization for Reallocation of Grant Funds.
In the event a sub-recipient is unable or unwilling to accept an
award of HOPWA funds, the funds may be reallocated to the next

eligible awardee using the same method and criteria normally applied by the Jacksonville Housing and Community Development Commission for award of HOPWA funds.

Section 4. Approval of Position. There is hereby
approved the Program Manager position more fully described in R.C.
24-003, attached hereto as Exhibit 3 and incorporated herein by this
reference. Said position is fully funded by HOPWA grant dollars and
will provide services in support of the HOPWA program.

9 Section 5. Effective Date. This Ordinance shall become
10 effective upon signature by the Mayor or upon becoming effective
11 without the Mayor's signature.
