PURPOSE: White Paper (Explain Why this legislation is necessary? Provide; Who, What, When, Where, How and the Impact.) Council Research will complete this form for Council introduced legislation and the Administration is responsible for all other legislation. (Minimum of 350 words - Maximum of 1 page.)

This legislation is necessary to revise Zoning Code Section 656.414 which addresses setbacks and yard requirements applicable to townhouses and rowhouses. The proposed amendment will provide different minimum lot width and maximum side yard requirements for 2-unit townhouses and rowhouses vs. townhouses/rowhouses containing more than 2 units. Specifically, the amendment provides that buildings containing more than 2 units must have a minimum lot width of 25 feet for end units and 20 feet for end units on buildings containing 2 units. In addition, buildings containing more than 2 units must have a 10 foot minimum side yard for end units and 5 feet for end units on buildings containing 2 units.


