5 **RESOLUTION 2023-318-A**

6 A RESOLUTION REAPPOINTING JILL D. HASKELL AS A  
7 MEMBER OF THE JACKSONVILLE WATERWAYS COMMISSION,  
8 AS A GENERAL PUBLIC REPRESENTATIVE, PURSUANT TO  
9 CHAPTER 95, *ORDINANCE CODE*, FOR A THIRD FULL  
10 TERM EXPIRING DECEMBER 31, 2024; PROVIDING AN  
11 EFFECTIVE DATE.

13 **WHEREAS**, Jill D. Haskell was initially appointed to the  
14 Jacksonville Waterways Commission ("JWC") pursuant to Resolution  
15 2015-134-A for a partial term ending December 31, 2015; and

16 **WHEREAS**, Ms. Haskell was subsequently reappointed to the JWC  
17 for a first full term ending December 31, 2018 pursuant to Resolution  
18 2016-816-A, and again for a second full term ending December 31, 2021  
19 pursuant to Resolution 2018-724-A; and

20 **WHEREAS**, in accordance with Section 95.103, *Ordinance Code*,  
21 Jacksonville Waterways Commission members from the general public  
22 serve for three-year staggered terms or until their successors are  
23 appointed by the City Council and may serve for up to three  
24 consecutive full terms; and

25 **WHEREAS**, while continuing to serve on the JWC for what would  
26 be considered her third term, Jill D. Haskell submitted a letter of  
27 resignation to JWC Chair Howland on February 7, 2023; and

28 **WHEREAS**, due to a change in circumstances, Ms. Haskell now  
29 wishes to resume her JWC appointment to complete the remainder of her  
30 third term, ending December 31, 2024; now therefore

31 **BE IT RESOLVED** by the Council of the City of Jacksonville:

1           **Section 1.       Reappointment.**   The Council hereby reappoints  
2 Jill D. Haskell, a Duval County resident, to the Jacksonville  
3 Waterways Commission, as a general public representative, in  
4 accordance with Chapter 95, *Ordinance Code*, for a third full term  
5 ending December 31, 2024.

6           **Section 2.       Effective Date.**   This Resolution shall become  
7 effective upon signature by the Mayor or upon becoming effective  
8 without the Mayor's signature.
