("USACE"), the State, through the FDEP, and the City. This appropriation reflects FDEP's cost share obligation for the Project.

Section 2. The purpose of the appropriation in Purpose. Section 1 is to receive and allocate FDEP's portion of funding for the Project which consists of the restoration and maintenance of approximately 10.1 miles of beach and dunes in Duval County, from the north end of Hanna Park to the south end of Duval County. renourishment projects are accomplished by need that can fluctuate per contemporary erosion rates and strong weather events, under normal conditions these projects occur approximately every five years. two most recent renourishments occurred in 2016-2017 and 2018-2019 after Hurricanes Matthew and Irma. The next "normal" renourishment was previously scheduled to occur in 2024 but is now being adapted to wholly repair beach and dune erosion that occurred from Hurricanes Ian and Nicole in fall of 2022 to the pre-storm (post-2019) renourishment condition. The Project will include a feasibility study, construction, and USACE's multiphase project.

Beach renourishment is governed by a Local Cooperation Agreement between the City of Jacksonville and the state and federal governments. Because much of the 2024 renourishment is necessary due to storm events, the federal cost-share will increase while the nonfederal portion will decrease. USACE will pay 100% of the beach berm repairs (estimated to be \$22,800,000) and the non-federal (FDEP and City) share will be 100% of the dune repairs (estimated to be \$6,700,000). Most of the non-federal costs will be expended over the next three fiscal years and much of it is eligible for reimbursement through FEMA and state sources.

A copy of the State of Florida Department of Environmental Protection Standard Grant Agreement (Agreement Number: 23DU1) (the "Agreement") providing the terms and conditions relative to receipt

and expenditure of FDEP funds for the Project has been placed **On File** with the Office of Legislative Services. The term of the Agreement commenced on April 1, 2021 and continues through March 31, 2026.

Section 3. Oversight. The Department of Public Works, Engineering and Construction Management Division, shall oversee administration of the Agreement described herein.

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
