## ORDINANCE 2023-401

AN ORDINANCE APPROPRIATING \$75,000.00 FROM A FLORIDA INLAND NAVIGATION DISTRICT (FIND) PROJECT FOR REED ISLAND TO PROVIDE FUNDING FOR INFORMATIONAL SIGNAGE TO WARN BOATERS OF SHOALING AREA; PROVIDING FOR DESIGN AND IMPLEMENTATION; PROVIDING FOR OVERSIGHT; AMENDING 2023-2027 FIVE-YEAR THECAPITAL IMPROVEMENT PLAN APPROVED BY ORDINANCE 2022-505-E TO REFLECT THE REDUCTION IN FUNDING FOR THE PROJECT ENTITLED FIND REED ISLAND; PROVIDING FOR CARRYOVER; PROVIDING AN EFFECTIVE DATE.

WHEREAS, from the mouth of Clapboard Creek southeastward toward the main channel of the St. Johns River, a sandbar or shoal ("shoal") has developed; and

WHEREAS, the shoal was not present 10 years ago, but has formed and is rapidly increasing in size and now encompasses approximately 7 to 10 football fields in length and about 1 football field in width; and

WHEREAS, at low tide in certain areas, the water is so shallow that sand is exposed, presenting a great safety risk to people and watercraft; and

WHEREAS, the Jacksonville Waterways Commission is committed to the protection of Jacksonville waterways and the citizens of Jacksonville; and

WHEREAS, the Jacksonville Waterways Commission finds that

warning signs placed in the shoaling area are necessary for the protection of the citizens; and

WHEREAS, warning signs must be permitted by Florida Fish and Wildlife Conservation Commission ("FWC") pursuant to Section 327.40, F.S., but FWC does not provide the signs or dictate the type of sign (whether a fixed piling with attached signs or a buoy anchored to the river bottom), so the decision as to the entity responsible for the cost of the placement and maintenance of the signs is left to the City; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2022-2023 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(The account information is attached hereto as **Exhibit 1** and incorporated herein by this reference)

(c) Explanation of the appropriation: The funding above is to provide \$75,000.00 from a FIND project for Reed Island whereby City matching dollars previously appropriated for the project are no longer needed as the project is not moving forward. The funds are instead being appropriated for the placement of warning signs in the shoaling area around the mouth of Clapboard Creek southeastward toward the main channel of the St. Johns River.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to permit, construct or purchase, and install signs notifying the boating public of the shoal that has developed in the

area around the mouth of Clapboard Creek southeastward toward the main channel of the St. Johns River. Any funds not utilized for this purpose shall be returned to the source of funding.

Section 3. Design and Implementation. To ensure boaters are aware of the dangers of the shoal in the area around the mouth of Clapboard Creek southeastward toward the main channel of the St. Johns River, the Parks, Recreation and Community Services Department, in consultation with FWC, and other interested city, state or federal agencies or departments, shall design and obtain necessary permits to install the warning signs at appropriate places to alert the boating public about the area. The Parks, Recreation and Community Services Department shall also implement the design for the placement of the signs.

Section 4. Oversight. Oversight of the professional services portion of this effort and the implementation of the design will be conducted by the Parks, Recreation and Community Services Department.

Section 5. Capital Improvement Plan Amendment. Ordinance 2022-505-E, adopting the 2023-2027 Five-Year Capital Improvement Plan (the "CIP") for the City and certain of its independent agencies, is hereby amended to reduce funding for the project entitled FIND Reed Island as more fully described in the Project Information Sheet attached hereto as Exhibit 2 and incorporated herein by this reference. The City Council finds that the deferral of this amendment of the CIP until the next annual budget and CIP review will jeopardize the safety of the citizens traveling this waterway and be detrimental to the overall best interests of the community.

Pursuant to Section 122.605(c), Ordinance Code, enactment of this Ordinance requires the affirmative vote of two-thirds of the City Council members present at the meeting because of the CIP amendment set forth in this section. This Ordinance shall constitute

an amendment to Ordinance 2022-505-E. In all other respects, the Five-Year Capital Improvement Plan approved by Ordinance 2022-505-E shall remain unchanged and continue in full force and effect.

Section 6. Carryover. The funds appropriated by this Ordinance shall not lapse but shall carryover to September 30, 2024.

Section 7. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
