WHEREAS, Nocatee West Commercial Retail (City Development Number 5389.45), also known as "Marketplace at Nocatee"," is a proposed grocery-anchored shopping center to be constructed on the

Section 1. Incorporating Recitals. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance upon adoption thereof.

Approval and Execution of Interlocal Agreement Section 2. authorized. There is hereby approved, and Mayor, or his designee, and the Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City, the Interlocal Agreement between City and SJC, in substantially the same form attached hereto as Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev Agmt, June 20, 2023 - NCSPHS" and incorporated herein by this reference (the "Agreement"), as authorized by Section 163.01, Florida Statutes. The Agreement may include such additions, deletions, and changes as may be reasonable, necessary, and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor or his designee, with such inclusion and acceptance being evidenced by execution of the Agreement by the Mayor or designee; provided however, no modification of the Agreement may increase the financial obligations or liability of the City to an amount in excess of the amount stated in the Agreement, and any such modification shall be technical only and shall be subject to appropriate legal review and approval by the Office of General Counsel. For purposes of this Ordinance, the term "technical changes" is defined as those changes having no financial impact to the City
