## ORDINANCE 2023-333-E

AN ORDINANCE CONCERNING THE RIVERSIDE AVENUE DRAINAGE STUDY; AMENDING THE 2023-2027 FIVE-YEAR CAPITAL IMPROVEMENT PLAN APPROVED BY ORDINANCE 2022-505-E TO MOVE THE RIVERSIDE AVENUE DRAINAGE STUDY FROM BEYOND FIVE YEARS TO FISCAL YEAR 2025-2026; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Riverside area experiences frequent flooding each year during heavy rain events and tidal surges which causes persistent roadbed deterioration on Riverside Avenue, Osceola Street, and Stockton Street; and

WHEREAS, there are plans to conduct a study in Riverside to evaluate drainage in the area to identify potential solutions to address this persistent flooding; and

WHEREAS, this study is included in the City's Five-Year Capital Improvement Plan ("CIP") as the "Riverside Avenue Drainage Study" project (the "Project") with an estimated completion date beyond the immediate five-year plan in Fiscal Year 2027-2028; and

WHEREAS, the City's Chief Resiliency Officer ("CRO") is currently undertaking a more global resiliency study to identify drainage, flooding, and other resiliency concerns throughout Jacksonville, and it is expected that this study may identify particular issues of concern in the Riverside area to help narrow the scope of the Project such that it might provide more effective and direct alternatives to address flooding in Riverside; and

WHEREAS, the Council desires to shift the timeline for the Project by moving it forward in the CIP to Fiscal Year 2025-2026 to

allow time for the CRO's study to be completed and analyzed for any impacts it may have on developing an appropriate scope for the Project while also avoiding an extended delay for this important study to be initiated and completed; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Capital Improvement Plan Amendment. Ordinance 2022-505-E, adopting the 2023-2027 Five-Year Capital Improvement Plan (the "CIP") for the City and certain of its independent agencies, is hereby amended to move the Riverside Avenue Drainage Study project from beyond five years to now occur in Fiscal Year 2025-2026, as more fully described in the Project Information Sheet attached hereto as Exhibit 1 and incorporated herein by this reference. The City Council finds that the deferral of this amendment of the CIP until the next annual budget and CIP review will be detrimental to the best interests of the community because such deferral would fail to demonstrate the importance of addressing the drainage issues along Riverside Avenue. Pursuant to Section 122.605(c), Ordinance Code, enactment of this Ordinance requires the affirmative vote of two-thirds of the City Council members present at the meeting because of the CIP amendment set forth in this section. This Ordinance shall constitute an amendment to Ordinance 2022-505-E. In all other respects, the Five-Year Capital Improvement Plan approved by Ordinance 2022-505-E shall remain unchanged and continue in full force and effect.

Section 2. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
