ORDINANCE 2023-410

AN ORDINANCE AMENDING RESOLUTION 73-1109-319, AS AMENDED, WHICH APPROVED A DEVELOPMENT ORDER FOR WESTLAKE, A DEVELOPMENT OF REGIONAL (DRI), PURSUANT TO AN APPLICATION FOR CHANGES TO A PREVIOUSLY APPROVED DEVELOPMENT OF REGIONAL IMPACT (AFC) FILED BY WESTLAKE LAND MANAGEMENT, INC., ET AL., AND DATED JUNE 9, 2023, WHICH CHANGES ARE GENERALLY DESCRIBED AS ADDING 19.37± ACRES (R.E. NOS. 003369-0010, 003369-0020, 003369-0030 AND 003373-0010) TO THE AMENDING THE MASTER DEVELOPMENT PLAN MAP H TO INCORPORATE THE ADDED PROPERTY AS A PORTION OF PARCEL 3 AND PROVIDING FOR LAND DRT USE CONVERSIONS; DIRECTING THE LEGISLATIVE SERVICES DIVISION TO FORWARD A CERTIFIED COPY OF THIS ORDINANCE TO THE AUTHORIZED AGENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Council adopted and approved the Westlake DRI Development Order by Resolution 73-1109-319, as amended; and

WHEREAS, Westlake Land Management, Inc., et al., has submitted an Application for Changes to a Previously Approved Development of Regional Impact (AFC), dated June 9, 2023, to the City requesting certain changes to the Westlake DRI Development Order; and

WHEREAS, if applicable, said AFC has been submitted to the appropriate state and local land planning agencies, and has been reviewed by the City's Planning and Development Department; and

WHEREAS, the Planning and Development Department has submitted recommendations regarding the proposed changes to the Westlake DRI Development Order; and

WHEREAS, the Land Use and Zoning Committee has reviewed the AFC and made its recommendation to Council; and

WHEREAS, the City Council finds that the proposed changes do not result in any additional adverse impacts from the originally approved DRI, as amended; and

WHEREAS, a public hearing was properly noticed and held by the Council pursuant to Section 380.06, Florida Statutes; and

WHEREAS, after such public hearing and in consideration of the recommendations made and submitted to the Council, the Council has made certain findings and determinations; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Development Order Amended. The Development Order for Westlake DRI is hereby amended to incorporate the proposed changes and modifications contained in the AFC dated June 9, 2023, and attached hereto as Exhibit 1, which changes are generally described as adding 19.37± acres (R.E. Nos. 003369-0010, 003369-0020, 003369-0030 and 003373-0010) to the DRI, amending the Master Development Plan Map H to incorporate the added property as a portion of DRI Parcel 3 and providing for land use conversions.

Section 2. Consistency. The Council hereby finds and determines that the changes and modifications set forth in the AFC dated June 9, 2023, are consistent with the 2045 Comprehensive Plan and the City's Land Development Regulations.

Section 3. Notice. The Legislative Services Division is hereby directed to forward a certified copy of this Ordinance to the authorized agent listed in **Exhibit 1**, attached hereto, upon its effective date.

Section 4. Effective Date. The enactment of this Ordinance
