5 AN ORDINANCE APPROPRIATING \$350,000.00  
6 (\$280,000.00 IN GRANT FUNDS FROM THE UNITED  
7 STATES DEPARTMENT OF TRANSPORTATION, FEDERAL  
8 HIGHWAY ADMINISTRATION, AND A \$70,000.00 MATCH  
9 FROM THE CITY FROM GENERAL FUND OPERATING FUND  
10 BALANCE) FOR THE SAFE STREETS AND ROADS FOR ALL  
11 GRANT PROJECT, AS INITIATED BY B.T. 23-109;  
12 PURPOSE OF APPROPRIATION; AUTHORIZING PART-TIME  
13 HOURS, AS INITIATED BY R.C. 23-162; PROVIDING  
14 FOR CITY OVERSIGHT BY THE PLANNING AND  
15 DEVELOPMENT DEPARTMENT; PROVIDING FOR AN  
16 EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:

19 **Section 1. Appropriation.** For the 2022-2023 fiscal year,  
20 within the City's budget, there is hereby appropriated the indicated  
21 sum from the account(s) listed in subsection (a) to the account(s)  
22 listed in subsection (b):

29 (c) Explanation of Appropriation:  
30 The funding above comprises \$350,000.00 in grant funds (the  
31 "Grant") from the United States Department Of

1 Transportation, Federal Highway Administration, and an  
2 additional appropriation of \$70,000.00 from General Fund  
3 Operating Fund Balance for the City match, for the Safe  
4 Streets & Roads for All Project (the "Project"). The Grant  
5 period commences June 2023 and ends February 2025.

6 **Section 2. Purpose.** The purpose of the appropriation in  
7 Section 1 is to provide grant funding for the Safe Streets and Roads  
8 for All Project which will develop an equitable and performance based  
9 Vision Zero Action Plan. The goal is to eliminate all roadway  
10 fatalities and serious injuries by 2030, including recommended  
11 policies and actionable items to be adopted by City leadership within  
12 one (1) year of completion of the Vision Zero Action Plan.

13 A copy of the Grant Award and Grant Agreement is attached hereto  
14 as **Exhibit 2** and incorporated herein by this reference.

15 **Section 3. Approval of Part-Time Hours.** There is hereby  
16 approved part-time hours more fully described in R.C. 23-162, attached  
17 hereto as **Exhibit 3** and incorporated herein by this reference.

18 **Section 4. Oversight Department.** The Planning and  
19 Development Department shall oversee administration of the Grant and  
20 shall provide oversight of the Program and part-time hours described  
21 herein.

22 **Section 5. Effective Date.** This Ordinance shall become  
23 effective upon signature by the Mayor or upon becoming effective  
24 without the Mayor's signature.
