This request is to extend the term of the FY 2022-2023 City Grant Agreement, approved via Ordinance 2022-504-E, by a period of 12 months, from October 1, 2022-September 30, 2023 to October 1, 2022-September 30, 2024. To-date \$42,000 has been disbursed for the grant and the MWP is current with its reporting obligations. Since the time the grant was awarded, the MWP has worked to finalize outreach and fundraising plans and develop collaborative partnerships in the community in support of their mission. Due to the timing of the Agreement, which was executed at the beginning of January 2023, the initial disbursement did not occur until the end of January 2023, resulting in delays finalizing contracts and plans. This amendment will allow the additional time needed to complete the deliverables. Further, the amendment better aligns the payment process with the needs of the organization, allowing for scheduled installments rather than reimbursements.
