AN ORDINANCE ADOPTING A SMALL-SCALE AMENDMENT TO 5 THE FUTURE LAND USE MAP SERIES OF THE 2045 6 7 COMPREHENSIVE PLAN BY CHANGING THE FUTURE LAND USE DESIGNATION FROM LIGHT INDUSTRIAL (LI) 8 ΤO 9 MEDIUM DENSITY RESIDENTIAL (MDR) AND CONSERVATION 10 (CSV) ON APPROXIMATELY 39.21± ACRES LOCATED IN 11 COUNCIL DISTRICT 11 AT 0 SALISBURY ROAD AND 7447 12 SALISBURY ROAD, BETWEEN SALISBURY ROAD AND 13 BAYMEADOWS CIRCLE WEST (R.E. NOS. 152578-0000 AND 14 152578-0010), OWNED BY CYPRESS PLAZA PROPERTIES, 15 INC. AND ALLSTATE ELECTRICAL CONTRACTORS, INC., 16 AS MORE PARTICULARLY DESCRIBED HEREIN, PURSUANT 17 TO APPLICATION NUMBER L-5844-23C; PROVIDING A 18 DISCLAIMER THAT THE AMENDMENT GRANTED HEREIN 19 SHALL NOT BE CONSTRUED AS AN EXEMPTION FROM ANY 20 OTHER APPLICABLE LAWS; PROVIDING AN EFFECTIVE 21 DATE.

23 WHEREAS, pursuant to the provisions of Section 650.402(b), 24 Ordinance Code, and Section 163.3187(1), Florida Statutes, an 25 application for a proposed Small-Scale Amendment to the Future Land 26 Use Map series (FLUMs) of the 2045 Comprehensive Plan to change the 27 Future Land Use designation from Light Industrial (LI) to Medium 28 Density Residential (MDR) and Conservation (CSV) on 39.21± acres of 29 certain real property in Council District 11 was filed by Wyman 30 Duggan, Esq. on behalf of the owners; and

WHEREAS, the Planning and Development Department reviewed the

1 proposed revision and application and has prepared a written report 2 and rendered an advisory recommendation to the City Council with 3 respect to the proposed amendment; and

WHEREAS, the Planning Commission, acting as the Local Planning Agency (LPA), held a public hearing on this proposed amendment, with due public notice having been provided, reviewed and considered comments received during the public hearing and made its recommendation to the City Council; and

9 WHEREAS, the Land Use and Zoning (LUZ) Committee of the City 10 Council held a public hearing on this proposed amendment to the 2045 11 Comprehensive Plan, pursuant to Chapter 650, Part 4, Ordinance Code, 12 considered all written and oral comments received during the public 13 hearing, and has made its recommendation to the City Council; and

WHEREAS, the City Council held a public hearing on this proposed 14 amendment, with public notice having been provided, pursuant to 15 Section 163.3187, Florida Statutes, and Chapter 650, Part 4, Ordinance 16 Code, and considered all oral and written comments received during 17 public hearings, including the data and analysis portions of this 18 proposed amendment 19 to the 2045 Comprehensive Plan and the 20 recommendations of the Planning and Development Department, the 21 Planning Commission and the LUZ Committee; and

22 WHEREAS, in the exercise of its authority, the City Council has 23 determined it necessary and desirable to adopt this proposed amendment 24 to the 2045 Comprehensive Plan to preserve and enhance present advantages, encourage the most appropriate use of land, water, and 25 resources consistent with the public interest, overcome present 26 deficiencies, and deal effectively with future problems which may 27 28 result from the use and development of land within the City of 29 Jacksonville; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville: Section 1. Purpose and Intent. This Ordinance is adopted

1 to carry out the purpose and intent of, and exercise the authority 2 set out in, the Community Planning Act, Sections 163.3161 through 3 163.3248, *Florida Statutes*, and Chapter 166, *Florida Statutes*, as 4 amended.

5 Section 2. Subject Property Location and Description. The approximately 39.21± acres are located in Council District 11 at 0 6 7 Salisbury Road and 7447 Salisbury Road, between Salisbury Road and Baymeadows Circle West (R.E. Nos. 152578-0000 and 152578-0010), as 8 9 more particularly described in Exhibit 1, dated June 20, 2023, and graphically depicted in **Exhibit 2**, both attached hereto and 10 incorporated herein by this reference (the "Subject Property"). 11

Section 3. Owner and Applicant Description. The Subject Property is owned by Cypress Plaza Properties, Inc. and Allstate Electrical Contractors, Inc. The applicant is Wyman Duggan, Esq., 1301 Riverplace Boulevard, Suite 1500, Jacksonville, Florida 32207; (904) 398-3911.

17 Section 4. Adoption of Small-Scale Land Use Amendment. The City Council hereby adopts a proposed Small-Scale revision to the 18 Future Land Use Map series of the 2045 Comprehensive Plan by changing 19 the Future Land Use Map designation of the Subject Property from 20 21 Light Industrial (LI) to Medium Density Residential (MDR) and 22 Conservation (CSV), pursuant to Application Number L-5844-23C.

23 Section 5. Applicability, Effect and Legal Status. The applicability and effect of the 2045 Comprehensive Plan, as herein 24 25 amended, shall be as provided in the Community Planning Act, Sections 26 163.3161 through 163.3248, Florida Statutes, and this Ordinance. All 27 development undertaken by, and all actions taken in regard to development orders by governmental agencies in regard to land which 28 29 is subject to the 2045 Comprehensive Plan, as herein amended, shall be consistent therewith as of the effective date of this amendment 30 31 to the plan.

Effective Date of this Plan Amendment. Section 6.

2 If the amendment meets the criteria of Section 163.3187, (a) 3 Florida Statutes, as amended, and is not challenged, the effective 4 date of this plan amendment shall be thirty-one (31) days after 5 adoption.

(b) If challenged within thirty (30) days after adoption, the 6 7 plan amendment shall not become effective until the state land planning agency or the Administration Commission, respectively, issue 8 9 a final order determining the adopted Small-Scale Amendment to be in 10 compliance.

Section 7. Disclaimer. The amendment granted herein shall 11 12 not be construed as an exemption from any other applicable local, state, or federal laws, regulations, requirements, permits or 13 14 approvals. All other applicable local, state or federal permits or 15 approvals shall be obtained before commencement of the development 16 or use, and issuance of this amendment is based upon acknowledgement, representation and confirmation made by the applicant(s), owner(s), 17 developer(s) and/or any authorized agent(s) or designee(s) that the 18 subject business, development and/or use will be operated in strict 19 20 compliance with all laws. Issuance of this amendment does not 21 approve, promote or condone any practice or act that is prohibited 22 or restricted by any federal, state or local laws.

23 Section 8. Effective Date. This Ordinance shall become 24 effective upon signature by the Mayor or upon becoming effective 25 without the Mayor's signature.
