**ORDINANCE 2023-514-E**

AN ORDINANCE REGARDING JAMES WELDON JOHNSON  
PARK; APPROPRIATING \$600,000 FROM A DESIGNATED  
SPECIAL COUNCIL CONTINGENCY ACCOUNT TO  
CONTRACTUAL SERVICES IN THE PARKS, RECREATION  
AND COMMUNITY SERVICES DEPARTMENT FOR JAMES  
WELDON JOHNSON PARK MAINTENANCE AND PROGRAMMING;  
AUTHORIZING THE OFFICE OF GENERAL COUNSEL AND  
THE COUNCIL AUDITOR'S OFFICE TO MAKE ALL CHANGES  
NECESSARY TO EFFECTUATE THE COUNCIL'S ACTION;  
PROVIDING AN EFFECTIVE DATE.

**BE IT ORDAINED** by the Council of the City of Jacksonville:

**Section 1. Appropriation.** For the 2023-2024 fiscal year,  
within the City's budget, there are hereby appropriated the indicated

2 Services Department appropriation made in **Exhibit 1** shall be used  
3 only for the purposes of maintenance and programming for James Weldon  
4 Johnson Park.

5           **Section 3.           Office of General Counsel and Council Auditor's**  
6 **Office Authorization.**   The Office of General Counsel and the Council  
7 Auditor's Office are hereby authorized to make all changes to titles,  
8 tables of content, Ordinance Code, journal entries, schedules,  
9 attachments, editorial and text changes consistent with the changes  
10 set forth herein to Ordinance 2023-504 to effectuate the Council's  
11 action.

12           **Section 4.           Effective Date.**   This Ordinance shall become  
13 effective upon signature by the Mayor or upon becoming effective  
14 without the Mayor's signature.
