31 **Section 2. Purpose.** The purpose of the appropriation in

1 Section 1 is to provide funding for Opioid Settlement Proceeds
2 Grants to be awarded to qualified requesting agencies in Fiscal
3 Year 2023-2024 in accordance with Chapter 84 (Opioid Settlement
4 Proceeds Grants), *Ordinance Code*. This funding comprises 40 percent
5 of the total Opioid Settlement Proceeds deposited in the Opioid
6 Settlement Special Revenue Fund created by Section 111.265,
7 *Ordinance Code*, as of July 1, 2023.

8 **Section 3. Effective Date.** This Ordinance shall become
9 effective upon signature by the Mayor or upon becoming effective
10 without the Mayor's signature.
