8 CITY COUNCIL MEMBER SALARIES AND BENEFITS FOR  
9 FISCAL YEAR 2023-2024; APPROVING POSITIONS;  
10 REQUESTING ONE CYCLE EMERGENCY PASSAGE;  
11 PROVIDING AN EFFECTIVE DATE.

13 **BE IT ORDAINED** by the Council of the City of Jacksonville:

14 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
15 within the City's budget, there are hereby appropriated the indicated

29 Section 1 above is to fund City Council Member salaries and benefits  
30 for fiscal year 2023-2024.

31 **Section 3. Approval of Positions.** There are hereby

1 approved the 19 positions more fully described in the R.C. attached  
2 hereto as **Exhibit 2** and incorporated herein by this reference.

3 **Section 4. Requesting One Cycle Emergency Passage Pursuant**  
4 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this  
5 legislation is requested. The nature of the emergency is that this  
6 funding was recommended by the Finance Committee during its August  
7 25, 2023, budget meeting. This funding was not included in Ordinance  
8 2023-504 due to a conflict of interest that would arise for two  
9 Council Members. Emergency action is requested so that this  
10 legislation can be taken up in conjunction with Ordinance 2023-504  
11 and approved as part of the City's budget package.

12 **Section 5. Effective Date.** This Ordinance shall become  
13 effective upon signature by the Mayor or upon becoming effective  
14 without the Mayor's signature.
