10 JANUARY 20, 2024, AS INITIATED BY B.T. 24-016;

13 **BE IT ORDAINED** by the Council of the City of Jacksonville:

14 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
15 within the City’s budget, there are hereby appropriated the indicated

27 Budget to support the MLK Week of Service programming to
28 be held January 13, 2024 through January 20, 2024 with its
29 co-sponsor United Way of Northeast Florida, Inc.

30 **Section 2. Purpose.** The purpose of the appropriation in
31 Section 1 is to provide additional funding for the MLK Week of Service

1 Program. The MLK Week of Service Program is a partnership between the
2 City and its co-sponsor United Way of Northeast Florida, Inc. to
3 organize community service activities aimed at uplifting the
4 underserved parts of Jacksonville by pursuing the goals of
5 neighborhood revitalization, improved financial well-being and
6 increased food distribution and honoring the legacy of Dr. Martin
7 Luther King, Jr. United Way of Northeast Florida, Inc. has received
8 an AmeriCorps grant to implement a day of service around the birthday
9 of Dr. Martin Luther King, Jr. These additional funds will allow
10 United Way of Northeast Florida, Inc. to expand the day of service
11 to a week of service in furtherance of the goals of MLK Week of
12 Service Program.

13 **Section 3. Effective Date.** This Ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
