

## NCSPHS AMENDMENT

The Neighborhoods, Community Services, Public Health and Safety Committee offers the following amendment to File No. 2023-671:

- (1) On **page 1, line 17**, after "ACCOUNT;" **insert** "PROVISION FOR THE FISCAL YEAR 2024-2025 BUDGET APPROPRIATION FROM THE FUND;"
- (2) On **page 1, lines 18-20**, **strike** "SOCIAL SERVICES DIVISION OF THE DEPARTMENT OF PARKS, RECREATION AND COMMUNITY SERVICES" and **insert** "GRANTS AND CONTRACT COMPLIANCE DIVISION OF THE FINANCE AND ADMINISTRATION DEPARTMENT";
- (3) On **page 2, line 13**, **strike** "who have recently become homeless or";
- (4) On **page 2, line 15**, after "\$1,500.00" **insert** "per calendar year";
- (5) On **page 2, line 21**, **strike** "fifteen percent (15%)" and **insert** "twenty percent (20%)";
- (6) On **page 2, lines 25-26 and page 3, lines 30-31**, **strike** "Social Services Division of the Parks, Recreation and Community Services Department" and **insert** "Grants and Contract Compliance Division of the Finance and Administration Department";
- (7) On **page 3, line 10**, **strike** "Exhibit 1" and **insert** "Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev B.T., October 16, 2023 - NCSPHS"";
- (8) On **page 3, lines 13 and 15**, **strike** "Exhibit 1" and **insert** "Revised Exhibit 1";

(9) On **page 3, line 29½, insert** a new Section 5 to read as follows:

**"Section 5. Fiscal Year 2024-2025 Budget Appropriation.** The Fiscal Year 2024-2025 budget appropriation from the Fund shall be an amount not-to-exceed twenty percent (20%) of the available balance within the Fund as of December 31, 2023. Thereafter, appropriations from the Fund shall be in accordance with Section 111.270, *Ordinance Code.*"

(10) Renumber the remaining Sections accordingly;

(11) Remove **Exhibit 1**, and replace with **Revised Exhibit 1**, attached hereto, which attaches the revised B.T. to correct account codes;

(12) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
