4 **ORDINANCE 2023-798**

5 AN ORDINANCE APPROPRIATING \$1,075,000.00 CONSISTING  
6 OF \$1,000,000 IN GRANT FUNDS FROM THE U.S.  
7 DEPARTMENT OF HEALTH AND HUMAN SERVICES, SUBSTANCE  
8 ABUSE AND MENTAL HEALTH SERVICES ADMINISTRATION  
9 ("SAMHSA"), AND A KIDS HOPE ALLIANCE ("KHA") MATCH  
10 IN THE AMOUNT OF \$75,000 FROM THE KIDS HOPE ALLIANCE  
11 GRANT FUND, FOR IMPLEMENTATION OF THE CO-DESIGNING  
12 RICH ENVIRONMENTS FOR ALL TO THRIVE EVERYDAY  
13 ("CREATE") PROGRAM, FOR THE FIRST YEAR OF THE FOUR  
14 (4) YEAR GRANT TERM BEGINNING SEPTEMBER 30, 2023  
15 THROUGH SEPTEMBER 29, 2027, AS INITIATED BY B.T. 24-  
16 019; PURPOSE OF APPROPRIATION; APPROVING A POSITION,  
17 AS INITIATED BY R.C. 24-011; AMENDING REVISED  
18 SCHEDULE M TO ORDINANCE 2023-511-E; INVOKING THE  
19 EXCEPTION TO SECTION 126.107(G), *ORDINANCE CODE*,  
20 WITH RESPECT TO SERVICES TO BE PROVIDED BY MANAGED  
21 ACCESS TO CHILD HEALTH, INC.; APPROVING, AND  
22 AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE  
23 CORPORATION SECRETARY, AND/OR THE CHIEF EXECUTIVE  
24 OFFICER OF KIDS HOPE ALLIANCE, TO EXECUTE AND  
25 DELIVER A CONTRACT WITH MANAGED ACCESS TO CHILD  
26 HEALTH, INC. FOR THE PROVISION OF PROFESSIONAL  
27 SERVICES FOR THE CREATE PROGRAM; WAIVING THE  
28 REQUIREMENTS OF SECTION 77.111(A) (PROVIDER  
29 CONTRACTS), CHAPTER 77 (KIDS HOPE ALLIANCE),  
30 *ORDINANCE CODE*, TO EXEMPT THE SERVICES TO BE  
31 PROVIDED BY MANAGED ACCESS TO CHILD HEALTH, INC.

1 FROM COMPETITIVE PROCUREMENT; PROVIDING FOR  
2 OVERSIGHT BY KIDS HOPE ALLIANCE; PROVIDING AN  
3 EFFECTIVE DATE.

5 BE IT ORDAINED by the Council of the City of Jacksonville:

6 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
7 within the City's budget, there is hereby appropriated the indicated  
8 sum(s) from the account(s) listed in subsection (a) to the account(s)  
9 listed in subsection (b):

16 (c) Explanation of Appropriation:

17 The funding above represents an appropriation of  
18 \$1,000,000.00 in SAMHSA grant funds for implementation of  
19 the Co-Designing Rich Environments For All To Thrive  
20 Everyday ("CREATE") Program, with an additional  
21 appropriation of \$75,000.00 from Kids Hope Alliance ("KHA")  
22 representing a local match for the first year of the grant.  
23 The overall grant term is four (4) years, with the first  
24 year beginning September 30, 2023 and ending September 29,  
25 2024.

26 **Section 2. Purpose.** The purpose of the appropriation in  
27 Section 1 is to provide funding for the first year of the CREATE  
28 Program for the period beginning September 30, 2023 through September  
29 29, 2024, and to procure the professional services of Managed Access  
30 to Child Health, Inc., to implement and carry out the CREATE Program.  
31 The CREATE Program is designed to provide mental health services for

1 children with serious emotional disturbances targeting children and  
2 youth with special health care needs, youth transitioning from  
3 pediatric to adult care, and LGBTQ+ children and youth.

4       **Section 3.       Approval of Position.** There is hereby approved  
5 the position more fully described in R.C. 24-011, attached hereto as  
6 **Exhibit 2** and incorporated herein by this reference. Said position  
7 is fully funded by SAMHSA grant dollars and will provide services in  
8 support of the SAMHSA program.

9       **Section 4.       Amending Revised Schedule M to Ordinance 2023-**  
10 **511-E.** There is hereby amended for the fiscal year 2023-2024 budget  
11 for KHA by substituting in the place of the Revised Schedule M,  
12 approved by Ordinance 2023-511-E, the Second Revised Schedule M,  
13 attached hereto as **Exhibit 3** and incorporated herein by this  
14 reference. The Second Revised Schedule M reflects the funds  
15 appropriated herein.

16       **Section 5.       Invoking the Exemption in Section 126.107(g),**  
17 **Ordinance Code.** KHA is hereby authorized to procure professional  
18 services from Managed Access to Child Health, Inc. for local  
19 implementation and administration of the CREATE Program in compliance  
20 with the grant described in Section 2 above. Pursuant to Section  
21 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126  
22 (Procurement Code), *Ordinance Code*, such services are exempted from  
23 competitive solicitation because the services to be provided are  
24 being approved via authorizing legislation pursuant to this  
25 Ordinance.

26       **Section 6.       Approval and Authorization to Execute.** The  
27 Mayor, or her designee, and the Corporation Secretary, and/or the  
28 Chief Executive Officer of KHA, are hereby authorized to execute and  
29 deliver a contract between KHA and Managed Access to Child Health,  
30 Inc. pursuant to which Managed Access to Child Health, Inc. will  
31 provide professional services necessary for local implementation and
